Respected sir,

With due respect I Madhuri Agarwal daughter of late Kashi Ram Agarwal resident of Masjid para Bagdogra Dakshin Bagdogra would like to draw your kind attention that harish Agarwal and myself in presence of family member of both the side got our marriage solemnized on 12 /05/2019 in presence of friends and family members , that since after marriage my mother in law did not like me much as Harish looked upon me with care and affection as we knew each other before marriage and had love among us. That on every occasion my mother in law had the habit of taunting about me and my family as I did not have father and was being looked by my mother who is a widow. That my mother in law on every occasion taunted that her son was not married to a good family and neither got any good amount dowry for her family neither the status was matched. That ignoring the same I tried to console myself that this was normal as may in law does that and to make the atmosphere of the family normal I kept silent on many occasion .

That keeping on mind that I am the eldest daughter in the family and my mother being widow on many occasion kept mum as to she had to look after my two younger brother who are dependent upon my mother, that I took this relationship with harish very seriously and as normal couple thought of a peaceful life in the form of supporting husband, but by the passage of time it seemed to be his regret to tie knots with me and on every occasion he along with his mother taunted me and challenged my character and modesty, on every occasion and started to avoid me in my matrimonial home at aforesaid mention address and toucher me mentally and use abusive language to me and my mother moreover my mother in law took into the custody of all the gold and valuable which was gifted to me by my mother on the occasion of marriage and when I asked for the same was refused by her to give and when I asked the same to my husband he got annoyed and started to use abusive language to me stating that I have played with the image and respect of my mother in law and to satisfaction of her ego my husband hit me with fist and blow and to which I too subsided as I was expecting and pregnant for one month even knowing this I was torcherd by them and this had aggravated my depression , but height have reached that after the delivery of the baby

boy on 17th day of September 2021 at aakash hospital.

I was humiliated and insulted by my mother in law and husband along with her kept on harping slang language to me despite of knowing my mental anxiety and depression, for which they even forced me to leave the matrimonial home and saying that " Bacha yah chod ke Jaa" which was another mental trauma for me, my husband even went to the extent of saying that he has been hacking my call details by using his influence as he is a Chartered Accountant and I came to my maternal home with my one month old baby, on 26th October 2021 my husband came to my house in a very aggressive manner banged the door and kept on kicking the door continuously for which I objected as it is matter of my reputation in the locality he used forced to take away the child from me saying that I am irresponsible mother and he threatened me to take away the child at any cost and threatened me that he will go to any extent to take the child from me even at the cost of my life, and this mental trauma is giving me suicidal thought due to hyper mental anxiety.

Therefore I request the authority to kindly take into immediate action against the aforesaid mention person as they are using force to take away my child from me and have traumatize me to that level that I am mentally unstable .
