house in and over the said land and house I along with my husband
Bhaktinagar, Dist. Jalpaiguri and I along with my husband
reside there and out of the said wedlock I gave birth of two male children
now they are aged about 8 & 6 years.

I would like to further inform you that although I have tried my level best to
adjust with my husband and other in-laws and I have discharged my all
duties as a wife towards my husband and in-laws and also as a mother to my
children but my husband and my other in-laws always used to mistreat
with me by abusing filthy languages which can not be uttered in a civilized
country including the physical abusing by my husband frequently with the
instigation of my other in-laws and gradually the said mental and physical
torture has been accelerated by my husband and other in-laws day by day
and sometimes it became intolerable.

I would like to further inform you that my husband and my other in-laws
have started to put pressure upon me to sale the said land and house for
meeting their liabilities and on refusal they continuously tortured upon me
for getting the consent to sale the said property and I was compelled to sale
the said land and house against the consideration a sum of Rs. 5,00,000/- and
they snatched the said consideration and enjoyed the same for their own use.

I would like to further inform you that in the month of October, 2019 my
husband shifted me at Jaldumur Danga Para, P.O. - Sahudangi Hat, P.S. NJP,
Dist. Jalpaiguri and after shifting there, my husband started to force me to
have sex with the different friends of my husband for earning money of my
husband and on refusal he started to assault me and on various occasions my
husband used to call his friends and they used to have alcohol and after that
my husband intentionally send his friend out of them in the bed room after
receiving money from them and also used to force me to mixup and sex with
such unknown persons and on refusal he used to assault me and due to such
brutal act of my husband, on 10.09.2021 I was compelled to leave the said
place with my minor sons for saving my chastity and modesty and I started
to reside with my parents again.

I would like to further inform you that yesterday i.e. on 29.10.2021 my
husband, his elder brother Sri Biswanath Barman, his married sister Smt.
Mina Roy, her husband Sri Ashit Roy, they all came to my place in the
evening at about 06:30 p.m. and after reaching there they all abused filthy

languages towards me and my family members and tried to take me back with them with an intention to engage me in the said immoral business to earn money and for their enjoyment and on refusal they assaulted me, my father, brother and mother by fist and blow and also my husband kicked me in my abdomen and I sustained injury and I was treated in Siliguri District Hospital and for that today in the morning at about 10:00 a.m. I was going to the medical shop for purchasing medicine as per the medical advice and its prescription dated 29.10.2021 and on the way at Thakur Nagar, Near Jaleswari Bazar, the nephew of my husband namely Smt. Bulti Das (Roy), W/o. Sri Utpal Das throttled my neck and assaulted me and for that I sustained blood injury on my face and for concealing the said blood injury she snatched my Orna (wearing) by which I covered my face and blood stain and I have been treated in Siliguri District Hospital.

Under the above circumstances I would like to request you to investigate the matter and do needful for giving a remarkable lesson to my husband and my above named in-laws for their brutal act for the ends of justice.
