In producing herewith one arrested accused person namely Joshna Barman(30) w/o Jyotish Barman of Roy Colony, Chayanpara, Ward No. 42, PS Bhaktinagar, Dist. Jalpaiguri along with the following seized articles as per proper seizure list:

1. Fourteen Pet Bottles of 60 UP Himalayan Gold Country Spirit each bottle containing 600 ml.

I, ASI Rabin Lama of Bhaktinagar PS, SPC would like to lodge a written complainant against the above noted arrested accused person to the effect that on 30.10.2021 at 14.45 Hrs received a source information that one lady namely Joshna Barman (30) w/o Jyotish Barman have gathered huge amount of liquor illegally in her shop named and styled as "Tara Hotel" situated at Sevoke Road, Opp Club Town Apartment under Bhaktinagar PS for selling the same to local customer for his wrongful gain. This refers to Bhaktinagar PS GDE No-1687 Dated 30.10.2021. Accordingly I, informed you about the information and as per your kind instruction, I along with LCV 314 Holika Roy, C/374 Debraj Biswas, CVF/ 619 Dharmendra Roy, CVF/614 Sumit Kumar Roy headed towards Sevoke Road to work out the information. At 14.55 hrs we reached at the spot, and after being identified by the source I, along with force held raid at the shop of Joshna Barman named and styled as Tara Hotel situated at Sevoke Road, Opp Club Town Apartment under Bhaktinagar PS and recovered the above noted seized articles. On demand she could not produce any valid license/documents in support of said liquor. During interrogation she admitted her guilt before us and stated that she has been selling the same to local people since long for her wrongful gain. I, then prepared seizure list of the above noted articles in presence of witnesses namely LCV 314 Holika Roy of Bhaktinagar PS/SPC and Bikram Chettri s/o Lt. Gyan Bahadur Chettri of Jyotinagar, Near Tarai Blood Bank, PS Bhaktinagar, Dist Jalpaiguri undersigned of seizure list. The seizure was made between 15.25 hrs to 15.55 hrs. I arrested the said accused person u/s 41 Cr.P.C after observing all the formalities and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you to kindly register a specific case against the accused person namely Joshna Barman(30) w/o Jyotish Barman of Roy Colony, Chayanpara, PS Bhaktinagar, Dist. Jalpaiguri under proper section of law.
