In producing herewith one arrested accused person namely Sanjit Mahato (20) s/o Jaynarayan Mahato of New Prakhnagar, Near Laboni Tailor, Ward No.43, PS Bhaktinagar, Dist. Jalpaiguri along with following seized articles;

- 1] One (01) Packet of Dadimas 3 Colour Rocket soundless Firecracker manufactured by Dadima Fireworks, Balarampur, Dist. 24 Parganas (each packet containing 10 pieces)
- 2] Five (05) packets of Lakhis Color Rocket manufactured by Lakhis Fireworks (each packet containing 10 pieces)
- 3] One (01) packet of Sri Vijai Colour Koti manufactured by Srivijai Pyrotechnic factory, Sivakasi (each packet containing 10 pieces)
- 4] Five 05 Packets of Sun Hydro Green, Sun Brand Trademark manufactured by Sun Enterprises Sivakasi (each packet containing 10 pieces)
- 5] Fourteen (14) packets of Meena electric Sparkles manufactured by Mohan Industries (each packet containing 10 pieces)
- 6] Three 3 Packets of Champion Flower Pots Big manufactured by Champion Fire works industries (each packet containing 10 pieces)

I, SI Prakash Saha of Bhaktinagar PS/SPC would like to lodge a written complaint against the above noted arrested accused person to the effect that on 31.10.2021 at around 14.15 Hrs received a source information about the storage and selling of huge amount of banned Firecrackers at one of the shop in Sahidnagar, under Bhaktinagar PS. Accordingly, I informed the matter to you and as per your kind instruction I, along with force left for Sahidnagar to work out the source information. At around 14.35 Hrs I, along with force reached Sahidnagar and as shown by the source I, along with force entered the Shop named and styled as "Maa Ganga Variety Stores" and apprehend one Shopkeeper who disclosed his identity as Sanjit Mahato (20) s/o Jaynarayan Mahato of New Prakhnagar, Near Laboni Tailor, Ward No.43, PS Bhaktinagar, Dist. Jalpaiguri and held raid and recovered above seized articles. On demand of documents or License in respect of the recovered Firecrackers he could not produce the same before us. During enquiry he stated that he has been selling the banned Firecrackers in his shop without valid Licence for Diwali Festival. Hence violating the provision of law and guidelines of Hon'ble Court I, seized the recovered Firecrackers from his shop in presence of witnesses duly signed by them and arrested the above noted accused person U/S 41 Cr.P.C. after appraising him the ground of arrest. (The seizure was made in between 14.55 Hrs to 15.45 Hrs)

I, therefore request you to kindly register a specific case against the accused person namely Sanjit Mahato (20) s/o Jaynarayan Mahato of New Prakhnagar, Near Laboni Tailor, Ward No.43, PS Bhaktinagar, Dist. Jalpaiguri under proper section of law.
