I, Nirmal Agarwal, s/o. Sri Rajaram Agarwal, resident of
North City, Opal Tower, Swoke Road, Siliguri - 734001, would
like to lodge the following complaint:

- i) That at around 10 PM, I entered North City premises
and parked my vehicle and went to my flat.
- ii) That after some time, my building guard informed
my father that some 8-10 people are enquiring about
me.
- iii) That I came down to look who was enquiring
about me. I got to know that one Rahul and 8-10
other people have forcibly entered North City premises.
As soon as these people saw me, they attacked me
and injured me badly and I started bleeding from
my head.
- iv) My family members rushed to save me and one
of my family members informed Bhaktinagar Police
station over phone regarding this incident.
- v) Then my father took me to Maharaja Agrasen Hospital
for medical examination. The report of the same has
been enclosed herewith.

I hereby request you to kindly lodge an FIR
against those people and take strict action against
them.
