Sub: FIR against miscreants


Sir,

With due respect, I Ajit Kumar Singh S/O Ram Sakha Singh of Jyotinagar colony, Champasari wants to inform you that today (01/11/2021) around 1:40pm three persons in a scooty with others entered my petrol pump premises and suddenly attacked on my staff namely Pankaj Mahato, Deepnarayan Yadav and Rakesh Ranjan who was on duty at that time. Among the said miscreants two persons have been identified as Sahil Khan and Sohail Khan both are S/O Jahangir Alam Khan resident of Debidanga near Masjid, Champasari. When the staffs tried to resist themselves then the said persons assaulted them mercilessly with sticks, lathi, etc. As a result the staffs received serious injuries on their person and they were treated at Siliguri District Hospital.

During this incident Sahil Khan and Sohail Khan took away Rs 80,000-90,000 from the collection bag of the staff namely Deepnarayan Yadav by attacking him.

I would like to request you to kindly look into this matter and take strict action against these people. I am attaching the hospital report of the three staff who have received injuries due to the attack and the CCTV video footage of the incident in a pendrive.
