With due respect and humble submission I Premila Lama, wife of Roshan Grung, resident of Bara Jharu Jote have come before you with a humble prayer and cry regarding my life threatening cause.

Sir, I am a 26 year old married women and my marriage was a love marriage and was solemnized in the year 2015 on 23rd February with Roshan Gurung, S/O LT. Ram Bahadur Gurung, Resident of Bhujia pani, Bagdogra VTC, P.O & P.S - Bagdogra, near Kolkata road (Being Mobile No. 8597030245, 9563927318) and after the marriage we started living together in my mother-in-law's house, but after 2-3 months of our marriage my husband started to torture me and treating with me very badly, He has a very bad habit of drinking, smoking marijuana regularly and after that he and my mother-in-law harass me and uses a very filthy words and I had no other option but to stay with my husband and mother-in-law forcefully.

It is pertinent to mention here that my life is a hell with my in-laws and my husband and in 2019 my husband went to foreign country Abu Dhabi to work there and used to come rarely and during that time also my mother-in-law used to torture me a lot. My mother-in-law also has a habit of drinking and after drinking she also assaults me.

It is also very painful to mention here that recently in the month of September 29th 2021, my husband came back from Abu Dhabi and after that my husband and other family members started to torture me mentally and physically out of limits and my husband comes home every night in a drunk condition and assaults me very badly. I am a patient with a severe disease of T.V in my brain and I am undergoing treatment, the prescription of which I have annexed herein with and doctors have asked me to under go proper treatment and take rest, but unfortunately I have not been provided with proper financial support from my husband to do my treatment rather he now a days on a daily basis punches me in my head, because of which I am undergoing very severe pain and other side effect, also my mother-in-law and my husband with the help of two of their relatives namely Sahil Rai and Sohil

Rai who also now a days are staying in my in- laws house assaults me and they somehow wants me to die as because they beats me in my head where I am having disease and so I am going through serious mental agony and pain and physical tortured.

It is pertinent to mention here that I am going under severe mental condition because of my husband and mother-in-law as they want to throw me away or kill me and my husband wants to get married to other girl, even my husband has affairs with others girl and my mother in law also supports my husband and wants him to get married to another girl and somehow they are trying to kill me to get rid of me ,I am passing my daily life with a life threat, also on 3rd of October my husband and mother-in-law along with Sahil Rai and Sohil Rai locked me in a room and very they badly assaulted me so that I would die, and after that they also threw me out of my in-laws house.

It is very painful to mention here that I have no other option but to die because of the torture of my husband and my mother-in-law and their family members as they harasses me and assaults me, they are also trying to stop my treatment, so that I would die soon.

It is also pertinent to mention here that my husband is telling me that he will retune to Abu Dhabi on 7th of November and finally leave me and left me to die and my mother-in-law is also giving me mental pressure because of which my brain has been unconscious many a times because of the disease in my brain and mental torture upon me.

I would beg before you, to please kindly look into this matter immediately and do the needful or else they would torture me to death.
