
- i) Indian currency cash Rs, 1,04,290/- (One Lakhs four thousand two hundred ninety) on different denomination.
- ii) Three sets of playing cards (total 156 pcs)
- iii) Two PCs electric bulbs (Old & use)
- iv) Three packets of Flaks cigarette.
- v) Old bed cover (02 pcs) with different color.

The brief fact of the case is that on 30.10.2021 night at 00.05 hrs received a reliable source information from source that some persons at Rangapani bazar under PS Bagdogra was playing gambling in one office of Babosaiyee Samity office located at Rangapani bazaar for their wrongful gain and wrongful loss to others. Accordingly the information in hand to the OC Bagdogra PS and as per his instruction I along with available officers and forces and mobile van party left PS, for Rangapani bazaar area to work out the information. The matter was diarized in Bagdogra PS GDE vide no 1459 dtd, 30.10.21. at around 00.40 hrs we reached to the above noted place and parked the vehicle in a considerable distance from the spot and contacted with source he point out the Samity office located at Rangapani bazaar we cordon and conducted raid at office of Babosaiyee Samity office located at Rangapani bazaar under Bagdogra PS.

During raid found the above noted accused persons were playing gambling using playing cards in exchange of money for the purpose of their wrongful gain to one and wrongful loss to the other inside the said office of Babosaiyee Samity. The playing area was surrounded by the raid party in presence of disinterested witnesses and on seeing the police party some of them able to flee away from the place but apprehended some of them above noted. On interrogation the accused persons confessed their guilt of playing gambling in exchange of money and were failed to produce any license or valid documents in support of their gambling. Accordingly, I seized the above noted articles from the spot under proper seizure list in presence of witnesses duly sign by them. The seizure was done in between 01.05 hrs to 01.50 hrs. Thereafter, I arrested all the above noted accused persons with proper memo of arrest and informed them ground of arrest. During interrogation the above noted persons admitted that they were playing gambling there before the commencement of Pre Kali Puja Puja festival 2021 for their wrongful gain and wrongful loss and the building belongs to office of Babosaiyee Samity located at Rangapani bazaar under Bagdogra PS all the miscreants uses the place/ building for using it as common gambling house.

Under the above facts and circumstances, I request you that a specific case against the aforementioned persons may kindly started with suitable sections of law.


