1, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 28.10.21 at 20.45 hrs I received a secret source information that one person namely Manas Ganguly is selling ID liquor illegally at his shop styled as Ma Hotel at NJP Rly Station for his illegal gain. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 1213 dated 28 10.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, HG/794 Ranjit Roy, VP/13 Jamirul Islam, VP/08 Laxman Roy, CV/306 Bisawajit Roy all of NJP PS, SPC left for Hotel Line, NJP to work out the information in hand. At about 21.05 hrs we arrived at Ma Hotel, NJP, PS-NJP, Dist.-Jalpaiguri and being shown and identified by the source I held raid at Ma Hotel and managed to apprehended one person who disclosed his identity as noted above and also disclosed that he is running the said hotel since long. During further interrogation he disclosed that he is selling ID Inquor at his shop-since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the 1/D liquor at his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between hrs 21.25 hrs to 22.15 hrs on 28.10.21.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Manas Ganguly (51 yrs) S/O late Birendra Chandra Ganguly of Chechakhata, Shib Mandir, PS- Alipurduar, Dist.- Alipurduar and arrange for its investigation.
