

Sir,

In producing here with one accused namely Pawan Singh S/O- Lt Chandrama Singh of Kalamjote, P.S- Matigara, Dist- Darjeeling under arrest and following seized articles under seizure-

1. 10 (ten) packets of Stars Dhoni power Chocolate MFG by St6ar Enterprise each packet containing 10 pieces.
2. 06 (Six) packet of Vaishnavi's King Cobra MFG BY Vaishnavi fireworks, Sivakasi 626189 Enterprise each packet containing 28 pieces.
3. 06 (Six) packet of Jugmug Chocolate Junior electric sound each packet containing 12 pieces.
4. 01 (one) packet of Vadivel Boomerang MFG by Vadivel pyrotechs (p) LTD. Each packet containing 3 pieces.
5. 01 (one) packet of Vadivel most wanted Zozo MFG by Vadivel pyrotechs (p) LTD. Each packet containing 3 pieces.

I, PSI Rantu Haldar of NBMC OP under Matigara Police Station Siliguri Police Commissionerate do here by lodged this written complaint against the above mentioned accused person namely Pawan Singh S/O- Lt Chandrama Singh of kalamjote, P.s- Matigara, Dist- Darjeeling to the effect that today on 03.11.2021 at 16.20 hrs received a secret information that one person namely Pawan Singh S/O- Lt Chandrama Singh of kalamjote, P.s- Matigara, Dist- Darjeeling has stored huge quantity of fire-crackers at his shop at Surya Sen Market area for selling the same to the open market for his wrongful gain without having any license or other valid documents in respect of the same, violating the provision of law which may endanger human life and likely to cause injury of human life. This refers to Matigara PS GDE NO -74 dated 03.11.2021 accordingly as per your kind order I along with ASI Dulal Dey and C/186 Manaranjan Singha all of NBMC OP PS- Matigara SPC rushed to the spot to work out the information. On the way to Surya Sen Market P.O- Sushruta nagar, P.S- Matigara Dist- Darjeeling I summoned two disinterested witnesses namely (1) Goutam Majumder S/O- Lt Rabindra nath Majumder of Thiknikatra, P.S- Matigara, Dist- Darjeeling (2) Mithu Singha S/O- Lt Hari ballav Singha of Kalamjote, P.S- Matigara, Dist- Darjeeling apprised them about the information in hand and on request they agreed to accompany us in the whole raid, search and seizure process if required.

On reaching at Surya Sen Market I contacted with my source and being guided and identified by the source apprehended one person with the above mentioned seized articles (fire crackers) being stored in his shop stayed as at Surya Sen Market stayed as " Joy Mata Cosmetic store " on interrogation he disclosed his identity as noted above, Further on demand he failed to produce any valid documents / license in

support of the possession of such quantity of fire crackers recovered from his shop there is a reason to believe that Pawan Singh has stored the said consignment of fire crackers for selling the same in the open market for his wrongful gain, which are combustible in nature and endanger top human life and property at his shop stayed as "Joy Mata Cosmetic Store" at Surya Sen Market illegally and violating Govt. Orders. Moreover the above noted fire crackers under proper seizure list duly signed by the witnesses and seizure was made between 17.40 hrs to 18.05 hrs. Subsequently, I arrested the above noted accused person observing all the formalities and informing the ground of arrest.

Under the above noted fact circumstance, I pray before you that a specific case may kindly be started against the accused person namely Pawan Singh S/O- Lt Chandrama Singh of Kalamjote, P.s- Matigara, Dist.- Darjeeling under proper section of law and arrange for its investigation.




