Respected Sir,

I, Jahangir Alam Khan, Son of Late Abdul Hamid Khan, of Debidanga Bazar, Puba
Para, P.O. Champa Sari, P.S. Pradhan Nagar, Dist- Darjeeling, would like to report
you the following facts:-

1. That on 01.11.2021 at 10.30 a.m. when my younger son namely Sahail
Khan (aged about 16 years) went to Maa Durga Petrol Pump and stood at
the line for taking petrol in his vehicle at that time one of the staff of Maa
Durga Petrol Pump intentionally by ignoring him continuously filling the
petrol in other person's bikes and vehicles, after several and repeated
request of my younger son the aforesaid petrol pump's staff did not give
him petrol but started abusing him in filthy and offensive languages when
my son resist him at time said petrol pump's staff along with other 4/5
staffs of the said petrol pump including the manager by catching his color
and neck assaulted him by fists, blows and by kicks brutally, they assaulted
my minor son like like animal for 15/20 minutes, after such incident of
mercilessly assault my younger son got fever and heavy body pain and now
he is bed ridden and unable to walk and follow the daily routine of his life,
and now he is under Doctor observation.

2. That after hearing the incident my elder son namely Sahil Khan at about 1
to 2 p.m. went to the said petrol pump for knowing the incident at that
time all of them (petrol pump's staffs including manager) by taking hockey
sticks in their hand started assaulting my elder son also and they without

hearing any words from him mercilessly assaulted him for about 30 - 40 minutes and in this hot altercation my son got head injury blood was oozing from his head including several body injury in his whole body.

3. That the aforesaid petrol pump's staff and manager forcefully snatched my elder son's neck chain made of gold weighing 10 grams and cash Rs. 3500/- from his pain pocket.

Sir, if in the said petrol pump CCTV camera are installed then you would get enough footage of the entire incident, so I request you to kindly take all the footage of the CCTV camera of the said petrol pump. Due to their such assault my both son received injury on their person and I took them at Siliguri S.D. Hospital for treatment, and now they are under medical observation.

I, therefore, requested you to kindly take necessary legal action in the aforesaid matter against the aforesaid culprits.
