

I, Riti Chhetri was searching for a job in Siliguri school's. This person said that he will help me to get a job in any government school of Siliguri or near by. He said to provide a photocopy of all the documents providing the documents, a few days later this person said that there is vacancies in some school and will help me to get the job, but an amount of Rupees 5 Lakhs has to be submitted partly, one part of Rupees 2 lakhs immediately and 3 lakhs after the government job is got or after appointment letter and joining is done. I asked a few days time period and applied for a loan (personal loan) through my husband's bank account. After the loan is approved we had a talk & said we cannot give him money with out an agreement. This person was ok to do an

agreement.

on, 05/07/2019 - we did an agreement and I handed over the money. The agreement of Rs 2lakh, which is submitted with application. After few days this person said the process had already started and inform us stage by stage.

After a few days my husband, Prawajit Chhetry was asking for about B.ED admission that time this person said he know some colleges members and can guide him for the B.ED admission. And later he will discuss about it after getting some information.

After a month this person again contacted us and said he will help my husband to get admission and all the admission process is ready and need to get admission immediately, and said to provide admission related required documents and amount of Rupees 1.50 lakhs. And we started to prepare the money ready. After arrangement of money we contacted this person and told that documents and money is arranged. He then there told that for school job more 50,000/- is to be submitted and we give a total of Rupees 2 lakhs to him trusting upon him without any agreement. He collected all the money and assured us that process is in progress and will inform us about the update's.

After few days suddenly he changed his rent and moved to another place near by. And then this person Manoj minj again changed his rent and had no contact us.

After one and half year suddenly we had a contact with him and asked him about the updates. This person said that still is in the process. We had a doubt about him and the work so told him to refund the money or show the relevant update documentations. Manoj told/called us in his new rented address - Kala boni,

-Debidanga, near Bharat gars godown.

On August month, we went to his rented house and had a talk with him about the job and B.Ed admission. While having talk this person Mahoj minj was suddenly very aggressive and started using vulgar language (shing language) and suddenly attacked me and shut my mouth. and suddenly attacked me and shut my mouth. with his hand. Then and there I started shouting and calling all the nearby person for help. I while shouting moved out of his house and closed the main door/gate to stop him. When I moved out of house I started calling all the nearby people for the help. My husband tried to hold this person but could not the person moved out of the house through the window by pushing my husband away from him. And flew away, since the grill/rod was not there in window. I also dialled 100 for help but no response.

Lastly, 23/september/2021, while I was travelling from Sevoke more to Debidanga through Auto. Suddenly Mahoj minj board the same Auto from Champasari more. After moving some distance I caught hold him and told him to lets go to the Police station or any update. Suddenly, he push me away to any way and flew away.

In view of above mentioned I would request you to lodge a complaint or FIR against this person. Phone number - 7501077800, 8250945906
