In producing herewith three (03) arrested accused persons namely 1) Md Washim Sk 18yrs s/o Md Hasmat Sk r/o Naya Busty PS, Kaliachak Dist, Malda 2) Md Tamiz 24yrs s/o Late Md Jalaluddin of Biswas Colony Matigara Ps Matigara Dist. Darjeeling 3) Md Ismile 34yrs s/o Late Md Saifuddin of Biswas Colony Matigara Ps Matigara Dist. Darjeeling along with following seized articles viz,

 One zipper transparent thin plastic packet in contents 263 grams (two hundred sixty three grams) said to be "Brown Sugar "Marked as Exhibit - "A".

 One zipper transparent thin plastic packet in contents 10 (Ten) grams of said to be "Brown Sugar which drawn from exhibit- "A" as sample for examination packed, sealed, labeled and marked as exhibit- "A-1".

1, SI Dipankar Chakraborty of Bagdogra Ps, Siliguri Police Commissionerate do here by lodged this complaint against the above mentioned three arrested persons to the effect that on 02.11.21 at 15.55 hrs received a secret source information that three persons having possession huge quantity of brown sugar are standing at Hansqua bazaar under Bagdogra PS, for clandestinely disposal of the same illegally. The matter was diarized vide Bagdogra Ps GDE No 1638 dt- 02.11.21. Accordingly, I informed the matter to O.C. Bagdogra PS as per his instruction myself along with ASI Dhirendra Nath Mandal, C/410 Montosh Singh, VP- 01 Ansalam Kujur, VP- 02 Pradip Roy, CV/389 Janak Singha, CV/375 Jogesh Barman, CV/923 Pandit Nagesia left for Hansqua bazaar area at 16.05 hrs to verify the veracity of the information vide corresponding Bagdogra Ps G.D.E. No. 1640 dtd 02.11.21

and Bagdogra Ps M.C.C No 3774 / 21 Dt, 02.11.21. At the time of departure from Police Station, I bring spring weighing clock, small balance with stone, envelope, paper, sealing wax, gum, seal etc for seizure labeled on the spot. On way to spot meanwhile I called two independent witnesses nearby at Hansqua bazaar namely i) Sri Gobinda Basak 23yrs s/o Barun Basak and ii) Sri Ajit Singha 25yrs s/o Ranjit Singha both of Kestopur Chowpukuria Ps Bagdogra Dist. Darjeeling those were standing near Hansqua more for green vegetable marketing informed them about the information in hand and requested them to accompany us to be remain as disinterested witness during the search and seizure if necessary. At about -16.30 hrs on arrival there by govt, vehicle (hired) parked the vehicle in a considerable distance as identified by the source we surrounded the place and found three persons were standing at Hansqua bazaar more near one chicken shop on seeing the police party they try to flee from there on hot chase, we apprehended the three persons. On being asked they disclosed their identity as noted above. After disclosing our identity I asked them whether they wanted to be searched in presence of Executive Magistrate or any Gazetted Officer and they agreed to search in presence by any of one. I served them option notice u/s 50 of NDPS Act accordance with provisions of law in this regard in writing and they also gave their approval of being searched by any of one in writing on the said option notice. Accordingly I informed the matter to O.C. Bagdogra Ps, regarding interception of three persons with contraband articles Brown Sugar and he informed me over mobile phone to send requisition to Sri Santanu Tarafder ACP, (AP) SPC, and special Executive Magistrate on the day. Accordingly, I send written intimation to Sri Santanu Tarafder ACP, (AP) SPC special Executive Magistrate on the day and request him to come down on the spot as early. At about 18.15 hrs Sri Santanu Tarafder ACP, (AP) SPC special Executive Magistrate on the day and O.C. Bagdogra Ps arrived at the spot. I disclosed the identity of Sri Santanu Tarafder ACP, (AP) SPC as special Executive Magistrate on the day to the accused persons and also witnesses. I offered the independent witnesses and the accused persons to search our Police Party as per provision of law. But they refused to search the police party. Under the supervision of Sri Santanu Tarafder ACP, (AP) SPC special Executive Magistrate on the day and O.C. Bagdogra Ps and in presence of independent witnesses, I conduct searched and recovered one zipper transparent thin plastic packet in contents said to be brown sugar which kept conceased on the pant pocket of Md Washim Sk. On demand he failed to produce any valid document in support of possessing of the same. On further interrogation Md Washim Sk confessed that the Brown Sugar he procured from Kaliachak Dist, Malda for clandestinely sale the same to his designated customers Md Tamiz and Md Ismile both of residing at Biswas Colony under Matigara PS, in a high rate during the pandemic situation in COVID-19.

Accordingly, I weight the recovered of zipper transparent thin plastic packet contents said to be brown sugar by the weighing instrument and found total 263 grms said to be brown sugar in the said plastic packet Marked as Exhibit - "A" and out of 10 Grams said to brown sugar taken as sample from the mother Exhibit - "A" in one separate thin plastic zipper packet and marked as "A-1". I sealed and labeled in presence of Sri Santanu Tarafder ACP, (AP) SPC special Executive Magistrate on the day and independent witnesses and accused persons. Then I selzed the above noted articles under proper seizure list and labeled duly signed by the above noted witnesses and the Sri Santanu Tarafder ACP, (AP) SPC special Executive Magistrate on the day and acknowledged by the accused persons. The seizure was made between -18.20 hrs to 19.15 hrs. On further interrogation the apprehended persons confessed in presence of Sri Santanu Tarafder ACP, (AP) SPC special Executive Magistrate on the day and other witnesses that Md Washim Sk procured the said brown sugar Chandestinely from Kaliachak Dist, Malda for disposal and supplied the same at Hansons bazaar to his designated customers/purchaser Md Tamiz and Md Ismile both of Biswas Colony Matigara PS, Matigara they called at Hansqua bazear also they addicted of Brown Sugar and also the purpose of selling in order to earn huge money quickly on their native village areas. Then I arrested the above noted three accused person's u/s- 41 Cr.P.C after observing all formalities of arrest as well as informed them regarding their cause of arrest and issued Memo of Arrest. The copy of seizure list and Memo of Arrest has been supplied to the above noted three accused persons under proper receipt as the accused persons violated the terms and condition of NDPS Act.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the accused persons namely 1) Md Washim Sk 18yrs s/o Md Hasmat Sk r/o Naya Busty PS, Kaliachak Dist, Malda 2) Md Tamiz 24yrs s/o Late Md Jalaluddin of Biswas Colony Matigara Ps Matigara Dist Darjeeling 3) Md Ismile 34yrs s/o Late Md Saifuddin of Biswas Colony Matigara Ps Matigara Dist. Darjeeling and arrange for its investigation.
