In producing herewith two arrested accused persons namely (1) Kanok Barman (28 yrs) S/O Mrinal Barman of Chhoto Shakdul, Basantir Hat, PS Sahibganj, Dist Cooch Behar (2) Dilip Barman (29 yrs) S/O Dayal Barman of Dighul Tam, PS Sahibganj, Dist. Coochbehar along with the following articles under seizure.

- i. One brown Color Paper made cartoon Containing 31 Kg said to be Ganja and marked as Exhibit "A".
- ii. One brown Color Paper made cartoon Containing 30 Kg said to be Ganja and marked as Exhibit "B".
- iii. One brown Color Paper made cartoon Containing 32 Kg said to be Ganja and marked as Exhibit "C".
- iv. One brown Color Paper made cartoon Containing 33 Kg said to be Ganja and marked as Exhibit "D".
- v. One brown Color Paper made cartoon Containing 32 Kg said to be Ganja and marked as Exhibit "E".
- vi. One brown Color Paper made cartoon Containing 25 Kg said to be Ganja and marked as Exhibit "F".
- vii. One brown Color Paper made cartoon Containing 27 Kg said to be Ganja and marked as Exhibit "G".

I, SI Samik Paul of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted two arrested accused persons to the effect that today i.e. on 02.11.21 at 18.10 hrs I received a secret source information that two persons is waiting for a vehicle at Fulbari Truck Parking area under NJP PS Dist Jalpaiguri with 07 (seven) Paper made Cartoons said to be Ganja with a view to go to Kolkata. Accordingly, I informed the fact to SI Samir Tamang, O/C New Jalpaiguri PS, Siliguri Police Commissionerate, and I diarized the fact in General Diary vide New Jalpaiguri PS GDE No 79 Dated 02.11.2021. Consequently, at 18.15 hrs myself along with SI Gautam Mallick, ASI Sajal Ray, ASI Khagan Barman C/453 Kishan Gurung, NVP/0064 Primal Roy, VP/08 Laxman Roy, VP/13 Jamrud Islam & CV/306 Biswajit Roy all of New Jalpaiguri PS, Siliguri Police Commissionerate left for Fulbari Truck Parking area to verify the veracity of the information in hand vide GDE No 80 dated 02.11.2021 & MCC No 2128/21 dated 02.11.21 by Govt. Vehicle taking all the necessary articles like white paper, Arrest Memo, Seizure List, seal, gala wax, candles, match box etc. At about 18.45 hrs we arrived at Fulbari Truck parking area and parked the vehicle there. Meanwhile, I called two independent disinterested witnesses namely 1) Biswajit Saha @ Chhoton S/O Ajit Kumar Saha of Bhaktinagar, Near Satsanga Asram, PS NJP, Dist Jalpaiguri and (2) Shri Soumya Bikash Ghosh S/O late Jyoti Prakash Ghosh of Phurba Dhantala, PS NJP Dist Jalpaiguri and I disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present as witness in whole process of search and seizure, if any in which they agreed. At about 19.45 hrs as identified by the source we noticed that two persons is standing inside Fulbari Parking area with 07 (Seven) paper made cartoons. We cordoned the place and managed to apprehended them. We disclosed our identity to the detained two persons and on being asked they disclosed their identity as noted above. I told them about the information in hand but initially they denied. Finally after prolonged interrogation they admitted that all the 07 (seven) cartoon in their possession containing Ganja. I then, served them option notice in writing that whether they wanted to be searched in presence and supervision of Executive Magistrate or police Gazetted Officer which they duly acknowledged by receiving and signing in the copy of Notice and they agreed to be search in presence of Police Gazetted Officer.
