In producing herewith accused persons namely 1) Jiarul Rahaman(40) s/o Lt. Abdul Majid of Paschim Dhantala, PS NJP, Dist. Jalpaiguri, 2) Anwar Islam (48) s/o Najibuddin of Amaidighi, Fulbari, PS NJP, Dist. Jalpaiguri, 3) Rafijul Haque (32) s/o Md. Parimuddin of Amaidighi, Fulbari, PS NJP, Dist. Jalpaiguri and 4) Praloy Das (38) s/o Lt. Nilmoni Das of Surya Sen Colony, Block "A", PS NJP, Dist. Jalpaiguri under arrest along with following seized articles:

- (1) Cash Rs. 11,560/- board money,
- (2) 03 (three) bundle playing cards
- (3) Usable plastic ground sheet
- (4), Burned candle.

I ASI Binay Subba of New Jalpaiguri Police Station, SPC would like to lodge a written complaint against the above noted accused person to the effect that on 03.11.2021 at about 19.35 hrs. received a secret source information that some persons were playing gambling in the godown near Jotikali Primary School. Accordingly I convey the matter to O.C. NJP PS and as per his kind direction, I ASI Binay Subba along with C/ 1041 Kishan Gurung, C/141 Hirendra Nath Roy left for Jotikali to verify the veracity of information vide M.C.C. No 2133/21 dated 03.11.2021 and on arrival at Jotikali being pointed out by the source I cordoned the said godown and found that the above noted accused persons playing gambling in the godown near Jotikali Primary School with the help of playing cards with a view to wrongful gain and wrongful loss. Seen our Police Van they are tried to flee away taking advantage of darkness. Anyhow, I manage to apprehended 4 (four) accused persons and rest are able to flee away from the said place. On searched I recovered (1) Cash Rs. 11,560/- board money, (2) 03 (three) bundle playing cards (3) one dot pen (4) usable plastic ground sheet, burned candle from the gambling board which was seized as per proper seizure list duly signed by them. Accordingly, I seized the above noted articles in presence of witnesses duly signed by them. Articles seized in-between 20.15 hrs. to 21.05 dated 03.11.2020 as per proper seizure list duly signed by the witnesses and accused person and prepared label. Accordingly, I arrested the above noted accused person U/S 41 Cr.P.C. and intimated the ground of arrest.

Under the above fact and circumstances I pray that a specific Case may kindly be initiated against 1) Jiarul Rahaman(40) s/o Lt. Abdul Majid of Paschim Dhantala, PS NJP, Dist. Jalpaiguri, 2) Anwar Islam (48) s/o Najibuddin of Amaidighi, Fulbari, PS NJP, Dist. Jalpaiguri, 3) Rafijul Haque (32) s/o Md. Parimuddin of Amaidighi, Fulbari, PS NJP, Dist. Jalpaiguri and 4) Praloy Das (38) s/o Lt. Nilmoni Das of Surya Sen Colony, Block "A", PS NJP, Dist. Jalpaiguri and arrange for its investigation.
