I, SIAzizul Haque of NJP PS, Siliguri Police Commissionerate do hereby lodged the written complaint against the above noted arrested accused person to the effect that today i.e. on 03.11.2021 at 2155 hrs I received a secret information that one person namely Arup Roy (31) S/o Kalidas Roy of Gopal More, Deshbandhu Para, PS- ward No. 30, PS- Siliguri, Disty.- Darjeeling selling Contrband Fireworks at Thanga More, Baribhasa for his illegain gain. Accordingly, I diarised the fact in General diary vide NJP PS GDE No 126 dated 03.11.2021 at 2205 hrs and informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC. As per kind order and direction of my superior Officers myself along with others available officers and force namely NVF/0065 Prakash Roy, NVF/0089 Shyamal Roy and NVF/0129 Majnu Md left for Thang Banga More, Baribhasa to work out the information in hand. At about 2225 hrs we arrived at Tanbanga More, Baribhasa, under NJP PS and being shown by the source I held raid at Aruop Roy and managed to apprehended the owner of the above noted shop. On search the above noted contraband Fire crackers recovered from his shop. On demand he failed to produce any valid documents in respect of the above noted contraband Fire crackers. During physical verification it is also found that the said illegal contraband fire crackers kept in his shop without any precautionary and safety measure. Accordingly, I seized the above noted illegal contraband fire crackers under proper seizure list and arrested the owner of the shop namely Arup Roy (31) S/o Kalidas Roy of Gopal More, Deshbandhu Para, PS- ward No. 30, PS- Siliguri, Disty.- Darjeeling under proper memo of arrest and observing all the formalities of arrest. The search and seizure made in between 2225 to 2315 hrs

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused person namely Arup Roy (31) S/o Kalidas Roy of Gopal More, Deshbandhu Para, PS- ward No. 30, PS- Siliguri, Dist.- Darjeeling and arrange for its investigation.
