With due respect, I am producing herewith one arrested accused person namely Dipak Barman (26yrs), S/O- Ukil Barman of Adarshapally, PO- Sahudangi hat PS- NJP, Dist - Jalpaiguri along with following seized fireworks /fire crackers under proper seizure list viz:

1. Jugmug Chocolate 11 bandels ,each bandels containing 06 packets 11*06=66 Pkts.
2. Lovely two sound three bandels ,each bandels containing 10 packets, 10*03=30 pkts.
3. Assam lion power chocolate three bandels , each bandels containing 05 packets, 05*03=15 pkts.
4. King kobra electric crackers 03 bandels, each bandels containing 50 pkts, 03*50=150 pkts.

I ASI Uday Sankar Bhattacharjee of Ambari Falakata OP , P.S- NJP under Siliguri Police Commissionerate do here by lodged the complaint to the effect that on today i.e. 04-11-2021 at afternoon receive source information that one Dipak Barman had been storing and selling the illegal fire crackers at his Shop at Adarshapally Bazar under this OP. Accordingly I informed the information to O/C ,Ambari Falkata OP and as per order by O/C Ambari Falakata vide Ambari Falakata OP GDE no-113, Dated: 04.11.2021 myself along with NVF/029 Kiran Roy, NVF/130 Dhanadeb Roy conducted raid against selling, storing of illegal fire crackers in the shop of Dipak Barman of Adarshapally Bazar as there was secret source information that he had been storing and selling the fire crackers of beyond permissible sound limit illegally to the customers. During raid apprehended one person who on being asked identified himself as Dipak Barman (26yrs), S/O- Ukil Barman of Adarshapally, PO- Sahudangi hat PS- NJP, Dist - Jalpaiguri and found him possessing above noted seized fire crackers kept concealed in this shop.

On being asked Dipak Barman admitted his guilt of purchasing, storing and selling of fire crackers at this Shop without licence. He also could not produce any documents in respect of huge amount of those fire crackers. The fire crackers were kept and stored without any precautionary and safety measure at this shop. The said stored fire crackers are combustible in nature and endanger to human life and property. So, I seized the fire crackers under proper seizure list duly signed by the witnesses. Accordingly, I arrested the above noted person u/s 41 Cr.P.C and acknowledge to the accused person. The seizure was made in between 15:45 hrs to 16:10 hrs.

Hence, I pray before you that a specific case may kindly be started against the above noted person namely Dipak Barman (26yrs), S/O- Ukil Barman of Adarshapally, PO- Sahudangi hat PS- NJP, Dist - Jalpaiguri under proper section of law and arrange for its investigation.
