With due respect, I am producing herewith arrested accused person who disclosed his identity namely Haradhan Ghosh (40 yrs) S/O Late Babul Ghosh of Jyotinagar Nagar Colony Bagan, Ward No. 4, PS- Siliguri, Dist- Darjeeling along with following seized fireworks /fire crackers under proper seizure list viz:

1. 10 Packets of Cracker styles as Akash Crackling Vinayak Fireworks, India Containing 10 pieces each.
2. 04 Boxes of Cracker styled as Flower Pots ( Super Deluxe ) Helogens ( Puja Traders, Belur ) containing 05 pieces each.
3. 05 Boxes of Cracker styled as original color,2121 Magic wrinkle sound containing 50 pieces each.
4. 09 packets of Cracker styled as Om flowers Pots,Giant Fireworks containing 10 pieces each.
5. 08 Packets of Cracker styled as RAT's Deluxe, Flower Pots Tharna containing 10 pieces each
6. 07 Boxes of Cracker styled as Masi MAA Spinner Deluxe Hi Speed containing 10 pieces each.
7. 04 Boxes of Cracker styled as Champion's Flower Pots Big containing 10 pieces each
8. 04 Boxes of Cracker styled as Gold Big ALAR Rasnay containing 10 pieces each.

I SI Uday Chakraborty of Siliguri P.S under Siliguri Police Commissionerate do here by lodged the complaint to the effect that on today i.e. 03.11.21 at 15.15 hrs receive information that one Haradhan Ghosh (40 yrs) S/O Late Babul Ghosh of Jyotinagar Nagar Colony Bagan, Ward

No. 4, PS- Siliguri, Dist- Darjeeling had been storing and selling the illegal fire crackers at the Shop situated at Jyotinagar Colony, Ward No. 04 under Siliguri PS. The matter was diarised vide Siliguri PS G.D.E no. 155/21 dated 03.11.21. Accordingly I informed the information to I/C Siliguri PS and as per order by I/C Siliguri P.S myself along with ASI Subir Sen, CV-283 Prosenjit Dey and CV-622 Ramanath Barman had been to the spot vide Siliguri P.S GDE no-156/21 Dated: 03.11.21. As per source information we conducted raid against selling, storing of illegal fire crackers in his shop that he had been storing and selling the fire crackers of beyond permissible sound limit illegally to the customers. During raid, we found that the above noted accused person was busy to sale the above noted seized articles. Accordingly I apprehended the above noted accused person who on being asked identified himself as noted above and found him possessing above noted seized fire crackers kept concealed in his shop.

On being asked the above noted accused person admitted his guilt of purchasing, storing and selling of fire crackers in his shop without licence. He also could not produce any documents in respect of huge amount of those fire crackers. The fire crackers were kept and stored without any precautionary and safety measure at his shop. The said stored fire crackers are combustible in nature and endanger to human life and property. So, I seized the fire crackers under proper seizure list duly signed by the witnesses. Accordingly, I arrested the above noted person u/s 41 Cr.P.C and acknowledge to the accused person. The seizure/label was made in between 16.15 hrs to 18.25 hrs.


