Sir,

With due respect, I am producing herewith arrested accused person who disclosed his identity namely Aman Kumar Singh (18 yrs) S/O Sri Samod Kumar Singh of Sishudangi near Sishudangi Prymari School, PS- Matigara, Dist- Darjeeling along with following seized fireworks /fire crackers under proper seizure list viz:

1. 70 Packets of Cracker styles as MA TARA's Mother India Electric Sparklers Containing 10 pieces each.
2. 20 Packets of Cracker styled as KAJAL's Flower Pots BIG containing 10 pieces each.
3. 15 Packets of Cracker styled as MASI MAA Spiner Big containing 10 pieces each.
4. 05 packets of Cracker styled as Om flowers Pots, Giant Fireworks containing 10 pieces each.
5. 25 Packets of Cracker styled as Sitala Green Premium Sparklers containing 10 pieces each.
6. 15 Boxes of Cracker styled as JUM JUMI Ground Chakkar Special containing 10 pieces each.
7. 10 Boxes of Cracker styled as MAA CHANDIS CHUTPUT containing 10 pieces each.
8. 06 Boxes of Cracker styled as Puja Chut Put containing 10 pieces each.
9. 06 Packets of Cracker styled as Nataraj Electric Sparklers containing 10 pieces each.
10. 20 Packets of Cracker styled as Gliting Premium Sparklers containing 10 pieces each.
11. 12 packets of Crackers styled as Star's Dhoni Power Chocolate containing 10 pieces each.
12. 12 Packets of Crackers styled as Trade Mark Dulal's Chocolate containing 10 pieces each.
13. 09 packets of Crackers styled Hologram Jugmug Chocolate Junior containing 10 pieces each.
14. 56 Packet of crackers styled as Bishal No.1 Chocolate containing 10 pieces each.
15. 76 Packets of Crackers styled as Balajis King Cobra Premium Chorsa containing 10 pieces each.

I ASI Siben of Siliguri P.S under Siliguri Police Commissionerate do here by lodged the complaint to the effect that on today i.e. 03.11.21 at 16.35 hrs receive information that one Aman Kumar Singh (18 yrs) S/O Sri Samod Kumar Singh of Sishudangi near Sishudangi Prymari School, PS- Matigara, Dist- Darjeeling had been storing and selling the illegal fire crackers at the Shop situated at Jyotinagar Colony, Ward No. 04 under Siliguri PS. The matter was diarised vide Siliguri PS G.D.E no. 159/21 dated 03.11.21. Accordingly I informed the information to I/C Siliguri PS and as per order by I/C Siliguri P.S myself along with ASI Subir Sen, ASI Dhruva Mishra and CV-283 Prosenjit Dey had been to the spot vide Siliguri P.S GDE no-160/21 Dated: 03.11.21. As per source information we conducted raid against selling, storing of illegal fire crackers in his shop that he had been storing and selling the fire crackers of beyond permissible sound limit illegally to the customers. During raid, we found that the above noted accused person was busy to sale the above noted seized articles. Accordingly I apprehended the above noted

accused person who on being asked identified himself as noted above and found him possessing above noted seized fire crackers kept concealed in his shop.

On being asked the above noted accused person admitted his guilt of purchasing, storing and selling of fire crackers in his shop without licence. He also could not produce any documents in respect of huge amount of those fire crackers. The fire crackers were kept and stored without any precautionary and safety measure at his shop. The said stored fire crackers are combustible in nature and endanger to human life and property. So, I seized the fire crackers under proper seizure list duly signed by the witnesses. Accordingly, I arrested the above noted person u/s 41 Cr.P.C and acknowledge to the accused person. The seizure/label was made in between 17.25 hrs to 19.10 hrs.

Hence, I pray before you that a specific case may kindly be started against the above noted arrested person namely Aman Kumar Singh (18 yrs) S/O Sri Samod Kumar Singh of Sishudangi near Sishudangi Prymari School, PS- Matigara, Dist- Darjeeling under proper section of law and arrange for its investigation.
