In producing herewith one arrested accused person namely Gouranga Chakraborty (58 yrs) S/O Lt. Subal Chakraborty of Vidya Chakra Colony, Ward No-44, PS Bhakti Nagar, Jalpaiguri along with following seized firecrackers under proper seizure list viz:

1. 37 (Thirty seven) Bundles of Dragon fight containing 37X10 = 370 packets style as Sri Ponmanis Mfd by Sri Panmoni fireworks.
2. 02(Two) Packets flash MOB style as Vadivel Mfd by Vadivel Pyrotechs (P) Ltd.
3. 01(one) Packet Sky shot Dual Dhamaka style as Big Ben Mfd by Sri Krishna Pyro exports (P) Ltd.
4. 02 (Two) Packets multi colour shots style as Baraat Ki Dance Mfd by Sri R.R fireworks.
5. 01(one) Packet Multi colour crackling 32 shots style as Guns of Navrang Mfd by Karthik fireworks Industries.
6. 02(Two) Packets Sky shot styles as Nirbhay Mfd by R.R fireworks.
7. 01(one) Packet Sky shot style as Brahmos Mfd by Sri R.R fireworks.
8. 01(one) Packet Multi Colour shot style as Krishna Leela 100 Mfd by Krishna Pyro exports (P)Ltd.

I ASI Gazi Rahaman of Panitanki TOP under PS-Siliguri/SPC do here by lodged the complaint to the effect that today on 03.11.21 at 18:05 hrs during evening RT mobile duty I receive source information that one Gouranga Chakraborty have been storing and selling the illegal fire crackers at Bidhan Market near Radha Gobinda Mandir under Panitanki TOP. Accordingly I informed the information to I/C Siliguri PS and as per order of I/C Siliguri PS myself along with ASI Biswajit Ghosh, ASI Surajit Mallick, CV-377 Dinesh Roy and CV 1009 Manoj Thakur had been to the spot and conducted raid against selling, storing of illegal fire crackers in the said area and found that the above noted person had been storing and selling the fire crackers of beyond permissible sound limit illegally to the customers. Accordingly I apprehended the above noted accused person who on being asked identified himself as noted above and found him possessing above noted seized fire crackers kept concealed beside Bidhan Market Radha Gobinda Temple.

On being asked the above noted accused person admitted his guilt of purchasing, storing and selling of fire crackers in his possession without any valid licence. He also failed to produce any documents in respect of huge quantity of those fire crackers. The fire crackers were kept and stored without any precautionary and safety measure. The said stored fire crackers are combustible in nature and endanger to human life and property. So, I seized the fire crackers under proper seizure list duly signed by the witnesses. Accordingly, I arrested the above noted person u/s 41 Cr.P.C and acknowledge to the accused person. The seizure was made in between 18.25 hrs to 19.10 hrs.

Hence, I pray before you that a specific case may kindly be started against the above noted arrested person namely Gouranga Chakraborty (58 yrs) S/O Lt. Subal Chakraborty of Vidya Chakra Colony, Ward No-44, PS Bhakti Nagar, Jalpaiguri under proper section of law and arrange for its investigation.
