Panam Saha, near Ramghat, Nuhungpara, ward no-5 SMC, P.O-Siliguri Bazar, P.S-Siliguri Dist-Dejalej and started abusing my elder brother namely, Bishadeu Roy (26) S/O Sri Brajen Roy, and when my mother namely, Smt. Anita Roy (40) W/O Sri Brajen Roy, & my sister namely, Smt. Santana Roy (24) W/O Sri Ajay Mehta, protested, they started beating them with fist and blades and kicked in the stomach of my said pregnant sister, Smt. Santana Roy.

My mother Smt. Anita Roy received severe injury on her person and treated at Siliguri Dist.H. Hospital.

The above named are co-tenants are very desperate & dangerous in nature and they have threatened us for dire consequences.

So, please take necessary action against them.
