This is to inform you that in the year 2019 I came contact with one Amit Kumar Das son of Ashok Das of Sukhaspally Siliguri near Netaji girls High School through Facebook gradually a friendship was developed. Sometime in the month of July - August 2020, the said Amit Kumar Das called me in his house when there was none in the house. He offered me some cold drink which I took and sometime there after I felt drowsy. Taking the advantage of the situation the said Amit Kumar Das tried to make physical relationship with me. Thereafter, frequently the said Amit Kumar Das putting pressure upon me to maintain physical relationship with him. On being denied by me the said Amit Kumar

Das is now threatening that he is in position of some unseen photographs of mine which he will publish and post in electronic media like facebook if I will agree to marry him.

Sir, I came to know that the said Amit Kumar Das wants to marry me with intention to grab the property of my father. During this period on several occasions the said Amit Kumar Das also assaulted me when I did not agree to meet physical relationship with him. He is continuously blackmailing me. Due to social prestige I kept myself mum and simply was avoiding him. Today at about 6:48 pm the said Amit Kumar Das sent a message from fake profile.

The print out copy of the said message is enclosed here with

Sir, I have been afraid after receiving the said message. The said Amit Kumar Das may publish some photographs which ~~may~~ may have been taken beyond my knowledge in facebook and other electronic media with intention to humiliate and maline me, as it is not possible for me to agree of his proposal.

You are, therefore, earnestly requested to do the needful and
