This letter is to inform you that I, Sanskriti Agarwal, daughter of Sanjay Kumar Agarwal, residence at 467, S P Mukherjee Road, Opp Gandhi Maidan Siliguri 734005, has received a message regarding a study from home to earn 2000-4000 on a daily basis. A whatsapp number was attached to the message. I dropped a message to the following person and he/she asked me to register and create an account on their portal. Initially, I was asked to recharge Rs 100 on the portal following which I received 200/- once I fulfilled the orders on their portal. Then, I recharged 1000/- and the same thing was repeated and 1300/- was credited to my account. After this, I recharged 5000/- and I was asked to recharge more and more for the orders to get fulfilled which amounted to around 94500/- at the end and I am still being asked to deposit more 40000/- to release all the amount. The whole conversation with the concerned person took place in whatsapp and telegram. Starting with whatsapp (8084595459) where I was asked to create an account at their portal and then I was asked to converse with a person in telegram who would guide me through the whole process.

The whole transaction took place from two different accounts. South Indian Bank registered in the name of Sanskriti Agarwal A/C No. 0396053000085083 for a total amount of 38,500/- which was transferred from Paytm Bank (link to mobile no. 7908245859) to goodluckcar@icici comprising a total 7 transactions. The details of the following are mentioned in the bank account statement attached to the letter.

The rest of the amount was transferred from my friend's account Ayush Mishra, for a total amount of 56000/- to two different upi ids which are:

- a) 50000/- transferred through Google Pay from ayushmishramangalam-1@okhdfcbank to anasokmail475canara@ikwik
- 6000/- transferred through Google Pay from ayushmishramangalam-1@okhdfcbank to 8185948700@hdfcbank

The portal shows all of my amount has been frozen and can be released only if I deposit more 40000/and finish the last order task. When I requested the person in telegram to release the amount, he/she asked to complete the last order task and then I will be able to withdraw the whole amount.

Therefore, I would like to request you to please look into the above matter and take strict action.
