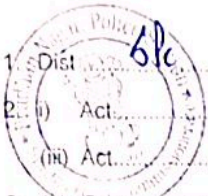

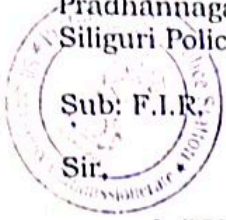

I, PSI Sumit Sarkar of Pradhannagar PS, SPC do hereby producing the arrested accused person namely Shibu Dey (47) s/o Lt. Amullu Dey of Matigara Road, Siliguri Junction PS- Pradhannagar Dist-Darjeeling along with seized Fire crackers viz; i) 09 Pkts. of Chakka lakka stars 12 shorts total = 108 Pcs, ii) 06 Packets of Rock Star Crackers each packets 12 Pcs, total= 72 pcs iii) 05 Packets of Ground Chakkar deluxe each packets contains 10 Pcs. total= 50 Pcs iv) 38 packets of Special Chutput each packet contains 10 Pcs total= 380 Pcs. v) 08 packets Mahimas ground Chakkar special each packets contains 10 Pcs. total=80 Pcs. vi) 05 Packets of Zamin Chakkar special styled as Jalpari each packets 10 Pcs. total=50 Pcs. vii) 03 packets of success penta magic each packets contains 05 pcs. total 15 Pcs. viii) 02 packets of sun feast magic Pot each packet contains 05 pcs, total= 10 Pcs., In this regard I beg to complain that today i.e 04.10.21 at 12.35 hrs received a secret information over telephone that one Shibu Dey owner of a Shop styled as Sarsata situated at Gate Bazar under Pradhan Nagarhe have been storing and selling of such banned Fire-crackers without having any license or other valid documents violating the provision of law, which may endanger of human life, likely to cause injury and may cause loss of public property of the area, I informed the matter to Inspector-in-charge SPC & ACP, west, SPC. As per their kind orders I accompanied with ASI Raju Sarkar, ASI Santanu Sarkar, , C 1446 Nirmal Roy C 1416 Dilip kr Barman rushed to the spot by govt. vehicle to work out the information. On arrival at Gate Bazar and contacted with source and as shown by source we cordoned the alleged shop.

Accordingly we conducted raid in the said shops of Shibu Dey. On searched I recovered above noted fire-crackers from the said shop. On being asked regarding storing and selling of banned Fire Crackers he could not produce any valid documents or licenses in support of the possession of such quantity of banned Fire Crackers recovered. It is pertinent to mention herein that the shop of above noted accused namely Shibu Dey is situated in the densely market area of Gate Bazar and its adjacent areas are also densely populated area, the accused was carrying such illegal business of banned fire crackers without any safety measure and without any permission from appropriate authorities, if any accident took place due to negligent act of the accused person that may cause huge loss of life and property of that area. The Fire crackers were stored without any precautionary and safety measure, thereby, violating the Section 285/286 of IPC and Section 24 of WBFS Act. Accordingly, I seized the fire crackers under proper seizure list in between 13:00 to 13:45 Hrs. And arrested the above noted accused persons U/S 41 Cr.P.C. And the seizure was made

Under the above circumstances, I pray before your kind end to start a specific case against the arrested person named Shibu Dey (47) s/o Lt. Amullu Dey of Matigara Road, Siliguri Junction PS- Pradhannagar Dist-Darjeeling and arrange for its investigation.
