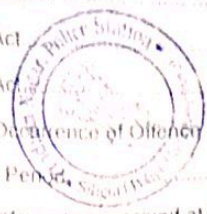



I, ASI Monoj Kr Roy of Pradhannagar PS, SPC do hereby producing the arrested accused person namely Wokil Singh (45) s/o Lt Ram Dayal Singh of Coolipara ward No 01, PS- Pradhannagar Dist-Darjeeling along with seized Fire crackers viz; i) 18 Packets of Jugmug Chocolate Junior pataka each packets containing 12 pcs. total= 216 pcs ii) 15 packets of Rino power chocolate pataka each packets contains 10 pcs total= 150 pcs. iii) 87 packets of King Cobra lanka pataka each packet containing 28 pcs. total =2436 pcs. iv) 10 packets of Chutput pataka each packet containing 10 pcs. tota= 100 pcs. v) 04 packets of Zamin charka special each packets contain 10 pcs. total = 40 pcs. vi) 05 packets of flower pots pataka each packets contains 10 pcs, total= 50 pcs, In this regard I beg to complain that today i.e 04.10.21 at 12.45 hrs received a secret information over telephone that one Wokil Singh owner of a grocery shop situated at Coolipara under Pradhan Nagar he have been storing and selling of such banned Fire-crackers without having any license or other valid documents violating the provision of law, which may endanger of human life, likely to cause injury and may cause loss of public property of the area, I informed the matter to Inspector-in-charge SPC & ACP, west, SPC. As per their kind orders I accompanied with ASI Maksud Ali, C 417 Rabindra nath Das C 880 Shymal Dutta rushed to the spot by govt. vehicle to work out the information. On arrival at Cooli Para and contacted with source and as shown by source we cordoned the alleged shop.

Accordingly we conducted raid in the said shops of Wokil Singh. On searched I recovered above noted fire-crackers from the said shop. On being asked regarding storing and selling of banned Fire Crackers he could not produce any valid documents or licenses in support of the possession of such quantity of banned Fire Crackers recovered. It is pertinent to mention herein that the shop of above noted accused namely Wokil Singh is situated in the densely market area of Cooli Para and its adjacent areas are also densely populated area, the accused was carrying such illegal business of banned fire crackers without any safety measure and without any permission from appropriate authorities, if any accident took place due to negligent act of the accused person that may cause huge loss of life and property of that area. The Fire crackers were stored without any precautionary and safety measure, thereby, violating the Section 285/286 of IPC and Section 24 of WBFS Act. Accordingly, I seized the fire crackers under proper seizure list in between 13:10 to 14:05 Hrs. And arrested the above noted accused persons U/S 41 Cr.P.C. And the seizure was made

Under the above circumstances, I pray before your kind end to start a specific case against the arrested person named Wokil Singh (45) s/o Lt Ram Dayal Singh of Coolipara ward No 01, PS- Pradhannagar Dist-Darjeeling and arrange for its investigation.
