THEST INFORMATION REPORT

To The Inspector-in-Charge, Pradhan Nagar Police Station, Siliguri Police Commissionerate.

Subject: F.I.R.

Sir,

Most respectfully I would like to inform you that, on the night of 04/05.11.2021 myself along with force were performing night mobile van patrolling duty (K-30). At 01.55 hrs I got information from SPC control as well as on duty officer of Pradhan Nagar P.S. that, a fire incident has taken place in few shops at in front of Siliguri Junction Railway Station behind Tensing Norgay Bus Terminal. Accordingly, myself along with force arrived at spot immediately and found a devastating fire arrested in shops in front of Siliguri Junction Railway Station. Subsequently, other officer and forces of Pradhan Nagar Police Station and two fire tenders of Siliguri Fire Station with staffs has arrived at the spot and stated extinguishing the fire. On that incident five numbers of hotels and others shops has been gutted totally and few damaged partially. One person has been succumbed over the fire in the Arjun Baisali Hotel cum Restaurant. It is coming to my knowledge from the local people that, the dyed person was locked at that hotel from outside by the owner. The body was immediately shifted to Siliguri Hospital and attending doctor also declared him as dead. The fireman and machineries become succeed to take control on the fire after over an hour's struggle extinguished totally by engaging three numbers of fire tender at around 03.30 hrs. Today afternoon I collected Preliminary Fire Report from the Officer-in-Charge, Siliguri Fire Station in which it is also mentioned that the person died in the hotel was locked from outside as per verbal statement of local peoples. The cause of fire could not be ascertained so far. So, it is clear that, the person could be rescued or managed himself to came out from the hotel if the shatter of the hotel could not be locked from outside by the owner of the hotel. The is gross negligence done by the owner of Arjun Baisali Hotel cum Restaurant which leads death of a person.

Hence, I pray before your kind honour to start a specific case under proper section of law against the owner of Arjun Baisali Hotel cum Restaurant of Siliguri Pradhan A Junction and arrange for it's investigation.



Analysis of fire fighting

After receiving the fire call over telephone, fire brigade reached the above fire spot speedily under Station Officer Mr. Ajit Ghosh of Siliguri F.S with 03 nos of fire tenders with crew. On arrival at the fire spot brigade found that 05 nos of different business occupancy in a series name Mukesh Hotel, Arjun Baisali Hotel cum restaurant, one tea shop, one saloon & one unidentified shop covering area about 1200 sq. ft., made of wooden and brick wall, C.I sheet roofing on wooden frame with iron shutter doors containing hotel and shop articles, furniture etc were involved in fire and well ablaze before arrival of brigade . Fire arrested from two corners by using two water jets and ultimately fire extinguished . One charred body name Ram Babu age about 40 years (Male) recovered from Arjun Baisali Hotel cum restaurant . The tea shop and saloon fully gutted and others partially damaged by fire. Charred body handed over to I.C., Pradhannagar P.S.

Observation.

- 1) No other trace of casualties/injured are reported .
- No fire safety measures are available there.
- 3) Police officers &personal were present at fire spot.
- 4) Cause of Fire: Could not be ascertained.
- 5) Local people verbally reported that Arjun Baisali Hotel cum restaurant was locked from out side.
