With due respect and humble submission, in producing herewith one accused namely Binod Thakur (31) S/O Sri Pralladh Thakur of Samarnagar, Near Sathi Sangha Club, P.S-Pradhannagar, Dist. Darjeeling under arrest along with following articles under proper seizure ;

- i) **18(Eighteen) Plastic bottles of Himalayan Gold ,Country Spirit ,60 up, each bottle containing 600 ML.**
- ii) **06 (Six) bottle of Kingfisher Strong ,Premium Beer ,each bottle containing 650 ML**

I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 06.11.21 vide PDN PS GDE NO 327 dtd. 06.11.21 while I was performing Special Mobile van duty with CV/128 Ajay Kr Sahani, CV/992 Jagadish Biswas , During mobile duty at 18.15 hrs I received an information that one person namely Binod Thakur has storage huge quantity of illegal liquor in his Hotel styles as Binod Hotel ,Blok-B-8. Ada Line , Regulated Marker under Pradhannagar PS and selling the same in his shop .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and hold raid in the shop noted above and detained the hotel of owner noted above and on being search his shop recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 18.35 hrs to 19:15 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Binod Thakur (31) S/O Sri Pralladh Thakur of Samarnagar, Near Sathi Sangha Club, P.S-Pradhannagar, Dist. Darjeeling and arrange for its investigation.
