With due respect and humble submission, in producing herewith one accused namely Suraj Mahato (29) S/O Sri Mahabir Mahato of New Pokajote ,Kath Bridge ,P.S-Pradhannagar,Dist.Darjeeling under arrest along with following articles under proper seizure ;

- i) **16(Sixteen) Plastic bottles of Himalayan Gold ,Country Spirit ,60 up, each bottle containing 600 ML.**
- ii) **07 (Seven) bottle of Officer Choice ,Deluxe Whisky ,each bottle containing 180 ML**

I ASI Debasish Das of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 06.11.21 vide PDN PS GDE NO 327 dtd. 06.11.21 while I was performing special Mobile van with CV/643 Pankaj Gupta ,CV/646 Baban Ch Das ,During mobile duty at 19.05 I received an information that one person namely Suraj Mahato has storage huge quantity of illegal liquor in his Hotel styles as DISCO Hotel,Blok-A Regulated Marker under Pradhannagar PS and selling the same in his shop .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and hold raid in the shop noted above and detained the hotel of owner noted above and on being search his shop recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 19.25 hrs to 20:05 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Suraj Mahato (29) S/O Sri Mahabir Mahato of New Pokajote ,Kath Bridge ,P.S-Pradhannagar,Dist.Darjeeling and arrange for its investigation.
