I, **SMT. SAMITA BARMAN**, Wife of Sri Taposh Barman and Daughter of Late Siben Barman, residing at Bhupendra Nagar, Ward No.42 of SMC, P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, do hereby lodge a complaint against my, husband, Taposh Barman, Son of Dhananjay Barman, father-in-law, Dhananjay Barman, Uncle-in-law, Anukul Barman, all are resident of Bhupendra Nagar, Ward No.42 of SMC, P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, to the effects as follows:-

- (1) That my marriage was solemnized on March, 2020 along with said Taposh Barman, Son of Dhananjay Barman of Bhupen Nagar, Ward No.42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri as per Hindu rites, rituals and customs and on the day of marriage, my parents and relatives gave Rs. 40,000/- in cash, Two Wheeler, Glamour, Hero Honda company, golden ear top, golden chain and golden ring, wooden bed, showcase, alna, wooden dressing table and other furniture, utensils, clothes and other things, articles etc. as stridhan and my husband and in-laws took me along with the aforesaid cash and articles.
- (2) That out of the aforesaid wedlock, I gave birth to a male child namely Deb Barman on 20-04-2021.
- (3) That after 4 months of marriage, I came to know that my husband is a habitual drunker, consumes ganja and drugs and regularly commit mental and physical torture upon me on the instigation and abetment of my above-named in-laws.
- (4) That on 15-10-2021 under the influence of alcohol, ganja and drugs, my husband committed torture upon me by sticks and slaps on the abetment of my in-laws and threatened me of killing me by throttling my neck by pillow and by electrocution and he also threatens my of killing my sister and her husband and my husband does not maintain me and child.

So, therefore, I humbly request you to take necessary legal action against my husband and said in-laws at an earliest.
