Sir,

In producing herewith one arrested accused person namely Dharambir Singh-45yrs s/o Naresh Singh of Sastrinagar, Tiranga More, ward no-41, PS Bhaktinagar Dist Jalpaiguri along with following seized articles viz:-

- (1) One paper cartoon containing 2.535 Kgs of Different type of Gutkha & Pan Masala

In this regard I beg to state that today i.e. 08.11.21 during my mobile van duty at PS area myself along with ASI Dipak Karmakar, Const/374 Debraj Biswas, CVF/614 Sumit Kumar Roy and CVF/935 Biplab Roy all of Bhaktinagar PS had been to Tiranga More Sastrinagar (This refers to Bhaktinagar PS GDE No-428 dated 08.11.21) and found that the above noted person selling banned Gutkha & Panmasla in his street shop style as Singh stores thereby violating the Govt of West Bengal order issued by office of the Commissioner of Food safety (Health & Family Welfare Department, Govt of West Bengal) vide order 355/HF/CFS/M-6/2012(pt.II) dated Kolkata 25.10.21 is as here quote "in pursuance of regulation 2,3,4 of the Food safety and standards (prohibition and Restrictions on sales) Regulations 2011 the manufacture, storage, sale or distribution of Gutkha and Panmasala containing tobacco and/or nicotine as ingredients, by whatsoever name it is available in the market, is hereby prohibited for a period of one year with effect from 07<sup>th</sup> day of November, 2021 in the State of west Bengal, in the interest of public health" Unquote.

When police team reached in the shop of the above noted person at Sastrinagar Tiranga More at about 19.10 hrs found that the person selling banned Gutkha and Pan Masala to the general public after violating Govt order. He is violating the Govt order which was passed with a view to stop the sell Gutkha and Panmasala upon the general public as it is injurious to public health. Accordingly I recovered and seized the above noted articles from his possession after preparing seizure list, labelled it duly signed by the witnesses and acknowledge by the accused persons also arrested Dharambir Singh-45yrs s/o Naresh Singh of Sastrinagar, Tiranga More, ward no-41, PS Bhaktinagar Dist Jalpaiguri u/s 41 Cr.pc after preparing proper arrest memo. Informed Inspector, Food & Safety, (Health & Family Welfare Department, Govt of West Bengal) but he is unable to appear the spot.
