I Shri PRAKASH SHIODAS NAGDEOTE an **widower** Ex-Serviceman and Retired Railway Accounts Officer, aged 62 years, belongs to SC community, have two daughters named SUCHITA NAGDEOTE and TRIPTI NAGDEOTE of ages 36 and 33 years respectively. I was living in my self acquired home at **TELIPARA PRIMARY SCHOOL ROAD, TELIPARA, PO. GHOGOMALI. DISTT. JALPAIGURI, PIN-734006**, which was forcefully acquired by my younger daughter TRIPTI NAGDEOTE, (aged 33 years) as a GIFT by blackmailing, threatening to my life and well planned conspiracy with her husband ARINDAM ROY (aged 33 years) in the month of November 2020. They came to Siliguri from their permanent residence at "FLAT NO S-1, PLOT NO 5/382, BRAHMAPUTRA LANE, SECTOR -5, GHAZIABAD, UTTAR PRADESH. PIN. 201010." in the month of June 2021 and started to live with me.

While living with them since June 2021, they both often illtreated, misbehave with me using filthy language, keeping me without food, no liberty of cooking food, stuck me into one room by taking all over control of the home and also threaten me to leave the home. On the night of 25th October 2021, we had a quarrel on the property issue, in response, they use filthy language saying that, now, this home is their I have no right to stay there. TRIPTI NAGDEOTE, demanded me the rent for the months I lived therein my home. Meanwhile, ARINDAM ROY was recording in his mobile phone, they also forced me to answer their question which was not related to this property. In fit of anger, I used pestle to stop him, in response, Arindam beats me, throwing on floor with slapping on left side of head and also snatched my Smart phone throwing it of floor and broken it in a bad shape with his feet as the phone contains evidence regarding property issues. All the events were recorded in the CCTV of Hall Room, if it was on. He called the police, I have not protested, because I was alone and put me in lockup by the police. Next day, when I went to home to get my belongings with my elder daughter SUCHITA NAGDEOTE with her husband, they treated us as outsiders and thieves also threaten us to live the home immediately. They also search my bag and belongings before leaving the home. Since I am in shock by their behaviour after acquiring my self acquired property of market value to Rs. 80 Lakhs, which acquired by them with planned conspiracy, blackmailing and threatening to my life.

Sir, I am a patient of high BP, Vertebral fracture and also suffered from mini stroke hence can't stand for long time and now by beating and slapping me on my left side of head, I suffering from sever headache and affected visibility of left eye. I am presently living at the rented house at **EAST VIVEKANANDA PALLY, RAJA RAM MOHAN ROAD, NEAR FRIENDS UNION CLUB, HAKIMPARA, SILIGURI. DISTT. DARJEELING. PIN 734001**

In the above circumstances, I requeste to your good self, kindly take the suitable action under suitable section of the **Welfare and Maintenance of Parents and Senior Citizens Act 2007 and relevant IPC** for assaulting and hurting me with broking my mobile phone (which has the evidence). Furthe,r requesting to ensure the safeguards of all households which are acquired by me, left behind in the home.
