I, ASI Rabin Lama of Bhaktinagar PS, SPC would like to lodged a written complainant against the above noted arrested accused person to the effect that on 09.11.2021 at 16.55 Hrs received a source information that one Goutam Roy of Uttar Ektiasal has gathered huge amount of ID liquor illegally in his house under Bhaktingar PS for selling the same to the local customer for his wrongful gain. This refers to Bhaktinagar PS GDE No-475 Dated 09.11.2021. Accordingly, I informed you about the information and as per your kind instruction, I along with C/374 Debraj Biswas CVF/619 Dharmendra Roy headed towards Uttar Ektiasal to work out the information. At 17.25 hrs we reached at the spot, and after being shown by the source I, along with force entered the house of Goutam Roy and found that he was selling the illegal liquor to the customers inside his house. After seeing the Police team the customers managed to fled away from the spot but we managed to apprehend above mentioned person namley Goutam Roy s/o Lt. Khagendra Nath Roy of Uttar Ektiasal, Near Battola, Ward No. 40, PS Bhaktinagar, Dist. Jalpaiguri and searched his house and recovered the above noted seized articles. On demand he failed to produce any valid license/documents from the appropriate authority for storing or selling liquor. During interrogation he admitted his guilt before us and stated that he has been selling the same to local people since long for his wrongful gain. I then prepared seizure list of the above noted articles in presence of witnesses undersigned of seizure list. The seizure was made between 17.45 hrs to 18.05 hrs. I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.
