Darjeeling, (5) Md. Sahel, Son of Md. Chand, (6) Rejina Khatun, Wife of Md. Sahel of Naxalbari, Dist. Darjeeling, (7) Saheran Khatun, Wife of Raju of Balurghat, (8) Pinki Khatun, Wife of Md. Irak of Muni Basty, Bagdogra, P.O. & P.S. Bagdogra, Dist. Darjeeling.

Respected Sir,

I Rukshana Begam, Wife of Md. Jabbar, D/o Md. Jalal @ Md. Jalal Khan (Mobile No.8653873420), presently residing at C/o Pusida Begam, Matigara Dry Fish Market, Khopalashi, P.O. & P.S. Matigara, Dist. Darjeeling, beg to report you the follows facts:-

- 1) That Md. Jabbar, Son of Late Md. Ishaque @ Md. Ishaque Haque @ Md. Ishaque Ali of Halal Jote, Halal, Chaupukuria, P.S. Phansidewa, Dist. Darjeeling is my legally married husband. Our marriage (Nikah) was solemnized on 24.10.2019 as per Muslim law, rites, rituals and customs at my father's house at Matigara Dry Fish Market, Khopalashi, P.O. & P.S. Matigara, Dist. Darjeeling and our marriage was registered before the Muslim Marriage Registrar and Kazi, Siliguri on 25.10.2019.
- 2) That my father gave cash Rs.3,00,000/-, different gold ornaments total weighing 2 (two) bharis, different silver ornaments total weighing 16 (sixteen) bharis, one LED TV, one teak wooden dressing table, one teak wooden dinning table, one steel Godrej almirah and different clothes, bed and beddings and utensils to my husband at the time of marriage as per the dowry demand of my husband and my mother-in-law Selaha Khatun.

- 3) That after marriage my husband took me to my in-laws house at Halal Jote, Halal, Chaupukuria, P.S. Phansidewa, Dist. Darjeeling and we started to live / reside there together as husband and wife.

In my in-laws house my mother-in-law Selaha Khatun, my two sisters-in-law (nanad) Mahiran Khatun, Wife of Md. Chand, (4) Khariul Khatun, D/o Late Md. Ishaque @ Md. Ishaque Haque @ Md. Ishaque and Md. Sahel (who is the nephew of my husband S/o Md. Chand) are also residing in my in-laws house.

Saheran Khatun, Wife of Raju of Balurghat and Pinki Khatun, Wife of Md. Irak of Muni Basti, Bagdogra, P.O. & P.S. Bagdogra, Dist. Darjeeling are my another two married sisters-in-law (nanad)

Rajena Khatun, Wife of Md. Sahel of Naxalbari, Dist. Darjeeling is the niece of my husband.

- 4) That since after 15 (fifteen) days of my marriage my husband, my mother-in-law, my aforesaid 4 (four) sisters-in-law (Nanad) and the aforesaid niece and nephew of my husband (Rejina Khatun and Md. Sahel) started to torture me both physically and mentally. They used to pickup quarrel with me without any reason and used to abuse me by filthy and insulting languages. They used to assault me by fists and blows and by kicks. They used to keep me in closed room and did not use to allow me to go out of doors of my in-laws house. They did not use to give proper and sufficient food to me in proper time and they also did not use to provide and give proper cloths to me for my use and wearing.

They used to raise questions on my chastity which gave tremendous pain to my body and mind.

Due to their such physical and mental torture upon me several times, I became ill and bed ridden.

- 5) That in the first part of the month of January, 2020, I became pregnant, and knowing this facts, my husband and my mother-in-law with the conspiracy of my aforesaid in-laws intentionally administered nostrum medicines to and upon me forcefully for terminating (for causing miscarriage) my pregnancy without my consent, and ultimately my pregnancy was terminated and caused miscarriage within short time, for which I sustained and suffered tremendous pain in my abdomen and vagina, and I was bed ridden for many days.

Their such acts and activities gave tremendous pain to my mind and I suffered trauma and ultimately be came agonized.

- 6) That their such physical and mental torture upon me was continued.
- 7) That my husband used to tell me that he had / has no love and affection for me and he did not like to see my face. He is addicted to drink alcohol and used to assault me mercilessly in drunken condition also.
- 8) That my husband's associates with and was associated with women of evil reput and leads and infamous life.
- 9) That my husband, my mother-in-law and my aforesaid in-laws used to attempt to force me to lead an immoral life in various ways.
- They used to obstruct me in of the observance of my religious profession and practice.
- 10) That their aforesaid physical and mental tortures, cruel act and physical ill-treatment upon me was increasing day by day.
- 11) That I again became pregnant 2nd time. In this time also my husband, my mother-in-law and my aforesaid in-laws attempted to administer nostrum medicine to me forcefully for terminating pregnancy against my consent but this time I anyhow restrained them from doing so and ultimately on 12.10.2020, I gave birth a male baby his name is Md. Rabiul Islam.

My husband did not bear and pay the medical expenses of mine during my pregnancy and another time of and after delivery of baby and the same has been borne and paid by my parents.

- 12) That they all used to use and throw filthy and dirty languages in the name of my son and in my name all times, which constantly gave pain to my mind and agonized and trauma.

I was subjected to cruelty and suffered physical and mental ill treatment and torture by them. They made my life miserable by their such cruelty and unlawful acts and activities.

- 13) That on 27.10.2021 at about 7:00 p.m. (night) my husband, my mother-in-law and my aforesaid in-laws assaulted me mercilessly by fists and blows and by kicks and my husband caught hold me and my mother-in-law put some

unknown tablets in my mouth and poured water in my mouth forcefully at a result of which same was ingested in my stomach. Thereafter, they drove me out from my in-laws house with threat by saying that they will murder me and my son, if, I enter into my in-laws house anytime in future.

Finding no other alternative, I came to my parent's house at Matigara, Dry Fish Market, Khopalashi, P.O. & P.S. Matigara, Dist. Darjeeling taking my son in my lap in empty hand only once set of wearing apparels which was in my person / body at that time and since then I have been living / residing there along with my son

Previously also, they forcefully administered some tablets to me forcefully for which my menstruation has been stopped.

- 14) That due to their such assault, I became ill and suffering from various pain and diseases which has been produced in my body from their such continuous assault and administration of nostrum in my body.


I have been under medical treatment at Matigara Govt. Hospital.

- 15) That I was very much ill and bed ridden in my parent's house so delay is cause to lodge this F.I.R., which may kindly be condoned.

I, therefore, request you to kindly take necessary legal steps against my husband, my mother-in-law and my aforesaid in-laws for their such commission of offence upon me.


