Dear Sir,

I want to report FIR after

being tortured by husband Praveen Lakra  
S/o Sri Anup Lakra and Smt. Aouna Lakra  
Cater No. 405/21 U/P  
d/1.08.11.21 u/p and Khalkho ; Vill + P.O - Sajnapara, Near - Gramin Bank,  
498 A 1/1c and P.S. - Dhupguri, Dist - Darjeeling Jalpaiguri; pin no -  
735212; W/B after marriage since 2017. He  
started beating me after a clash, hard talk  
and enquiry about the job and the salary  
chart, also unnecessary and unexpected calls  
from the people (his creditors) He abused my  
family and me and hit me on my head part.  
For this, being an epilepsy patient I had to  
suffer a lot. He wanted to kill me many  
times. He used to defraud and take me for the  
treatment and leave me with his relatives. He  
used to take my money and had parties such  
cocktail and all. He threatened that if I complain  
ed anyone he might shoot me with gun. He used  
my F.B accounts and pretending that it was  
me he tried to disrespect and abuse me to  
all my friends. He threatened my friends

and used many unexpected and unnecessary filthy (bad) words. He used to take things and money and give my personal number as a guarantor. I had to pay his debts being his wife. He cheated on his friends and many people in other states too. He also did sexual harassment. He used to insist me too, to mate with his known men. When I denied he used to hit me. He sold my Scooty, Meastro Hero no-WB74A K0327 which was certified in Edward Johnson Minj (brother's son). He sold my gold rings, PC, LED Monitors etc. He never used to give me monthly expense. He used my <sup>bank</sup> account and misused all money in that account. He had set up offices in city centre, Kawatkali (Siliguri) and in Jharkhand Rospa Tower. After all lose in his investment and parties. He claims huge money from me. He threatens me to pay him huge amount and threatens me with emotional torture. He is not with me since 2020 Jan. If he will be with me then I have to bear all his torture. He tried to abuse my Secretary sir Mr. Biman Chettri, Founder of Trinity B.ed college. He abused my friends too and became the hindrance to my career opportunities. I had applied for the divorce petition (mutual) He agreed before after taking sum of ₹ 1,00,000. He is trying to blackmail and demanding for more money.

I want justice and your help from (W.B) Siliguri Police. I shall be highly obliged. Your kind concentration is very important to me.
