Subject : F.I.R

This is to inform you that on 10th ^{November} October 2021 at around 7 pm, My Elder brother Ravi Sah and my father Sri Rajesh Sah aged 51 years were standing outside our house and doing puja rituals on occasion of Chhat Puja, all of a sudden few local gangsters viz. Manoj Sah S/o Ashoke Sah, Binod Sah S/o Ashoke Sah, Dipak Sah S/o Ashoke Sah, Manju Sah D/o Ashoke Sah, Anil Sah S/o Rameshwar Sah, Dipak Sah S/o Rameshwar Sah, Krishna Sah S/o Rameshwar Sah all residents of Kaat Pool, Pokhai Jote, Mallaguri came in full drunk condition and started unnecessary confrontation with my father, The matter came to my knowledge and I ran to the spot. They were more in numbers and those antisocial hit my full family, looted my house, broke my house furnitures, they physically assaulted me with rod, stones and wickets, they ran blade on my shoulder. Suddenly they took a Wooden Rod and came running towards us to attack, we started running to save our lives, but we suffered severe dorsal, neck and finger injuries. Any how we managed to escape from the spot with trembling legs and despair.

Sir, We are in complete mental shock and fear. We anyhow we managed to save our lives from those hooligans and outrageous antisocial and their "DADAGIRI".

Sir, my entire family is a victim of trauma, vandalism, gold chain snatching, money looting and above all unprecedented "dadagiri" of hooligans of Pokhai Jote.

Your immediate action his highly solicited, they have given life threats, SOS and oblige.
