Manoj Sah S/o Ashoke Sah, Binod Sah S/o Ashoke Sah, Dipak Sah S/o Ashoke Sah, Manju Sah D/o Ashoke Sah, Anil Sah S/o Rameshwar Sah, Dipak Sah S/o Rameshwar Sah, Krishna Sah S/o Rameshwar Sah all residents of Kaat Pool, Pokhai Jote, Mallaguri came in full drunk condition and started unnecessary confrontation with my father, The matter came to my knowledge and I ran to the spot.
