With due respect I, SRI SONTU SAHA, S/O Arajit Saha, resident of Pradhan More, North Ektiasal, Ward No. 40, P.O. Sevok Road, P.S. Bhaktinagar, District- Jalpaiguri, would like to lodge this written complaint to the effect that on 12.11.2021 at about 09:45 PM when my elder brother namely Sunoy Saha was coming from his work at that point of time Some persons namely 1) Bapi Roy, 2) Tapas Roy, 3) Joy Roy all are sons of Baisakhu Roy and 4) Sumon (thekua) all are residents of Battala, North Ektiasal, P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri, stopped my brother on the way and started to abuse him with filthy language and when he tried to stop them they started to assault my brother with fists and blows and after watching this I also rushed to rescue my brother but they also started to assault me badly and I sustained multiple injuries on my personal, thereafter said Bapi Roy and Tapas Roy brought an Iron Rod and knife with an intention to kill me and my brother and they attacked on my brother's face and as a result he sustained some grievous injuries on his personal and his nose is also broken and lips got severe cut injuries and also he sustained cut Siliguri Police Commissionerale injuries on his chest and they have taken cash Rs. 5000/- along with my Wallet from my pocket and they have snatched my silver chain moreover they did not stopped here he also assault me and my brother with bamboo stick and hearing the hue and cry local people
