Sir,

In producing here with the one accused person namely Bhupen Chandra Dey 38 years s/o late Sadhan Chandra Dey of Jyotinagar near Pateshwari School w/no 41 PS Bhaktinagar dist- Jalpaiguri along with Sixteen (16) bottles of Himalayan Gold 60 up country spirit each containing 600 ml as per proper seizure list:


I, ASI Rabin Lama of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complaint against the above noted accused person to the effect that on 13/11/2021 at 15.15 hrs received an information from source that one person namely Sadhan Dey of Jyotinagar has gathered huge quantity of illegal liquor in his shop at Sastri nagar, ITI road beside Polytechnic Girls Hostel, ward no 41 PS Bhaktinagar for selling the same to his design customers for his wrongful gain. Accordingly diarized the fact in GD vide Bhaktinagar PS GDE no 692 dated 13/11/2021 and shared the information with I/C Bhaktinagar P.S. and as per his kind instruction myself along with Constable 374 Debraj Biswas, CVF-614 Sumit Kr Roy and CVF-935 Biplab Roy, CVF, 619 Dharmendra Roy left for Sastri nagar to verify the veracity of the information. At about 15.25 hrs I along with accompanied force reached at the spot i.e. Sastri nagar ITI road beside of Polytechnic Girls hostel and as per being identified by the source our police party conducted raid in the shop of Bhupen Dey and recovered Sixteen (16) bottles of Himalayan Gold 60 up country spirit each containing 600 ml. On demand he could not produce any valid Licence/documents in support of said liquor. During interrogation he disclosed his name and identity Bhupen Chandra Dey 38 year's s/o late Sadhan Chandra Dey of Jyotinagar near Pateshwari School w/no 41 PS Bhaktinagar dist- Jalpaiguri and admitted that he has been selling the same to the local customer since long without any valid licence or Documents for his wrongful gain. Then I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 15.45 hrs to 16.05 hrs. As he violated the rules and norms of Bengal Excise Act as such I arrested the accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may be started against the accused person namely Bhupen Chandra Dey 38 years s/o late Sadhan Chandra Dey of Jyotinagar near Pateshwari School w/no 41 PS Bhaktinagar dist- Jalpaiguri under proper section of law and arrange for its investigation.
