Sir,

In producing herewith one arrested accused person namely Ruk Bahadur Mukhiya (32) S/O Lt Lal Bahadur Mukhiya of Dimdima Busty, Perna School, PO Salugara, Ps .Bhaktinagar, Dist. Jalpaiguri along with following seized articles:-

- (i) 09 (Nine) bottles of "Royal Blue Premium Whisky each bottle containing 750 ML
- (ii) 09 (Nine) bottles of Royal Blue Premium Whisky each bottle containing 180 ML
- (iii) 12 (Twelve) bottles of Old Monk Deluxe XXX Rum each bottle containing 180 ML.

In this regard, I beg to report that on 13.11.21 at about 23.45 hrs. Myself along with other officers and force were engaged on mobile van duty at PS area (This refers to Bhaktinagar PS GDE No-710 dated 13.11.21) and received information that one person was waiting for vehicle with huge quantity of illicit liquor at Bedgara road, in front of Kendriya Vidyalaya under Bhaktinagar PS for transporting the same. After receiving the information I informed the matter to I/C Bhaktinagar PS and as per his kind order and instruction I conducted raid at Bedgara road in front of Kedriya Vidyalaya and apprehended one person namely Ruk Bahadur Mukhiya also recovered (i) 09 (Nine) bottles of "Royal Blue Premium Whisky each bottle containing 750 ML (ii) 09 (Nine) bottles of Royal Blue Premium Whisky each bottle containing 180 ML (iii) 12 (Twelve) bottles of Old Monk Deluxe XXX Rum each bottle containing 180 ML from his possession. During raid I found that the above noted arrested accused were possessing the above noted articles and selling it to the customers since long for wrongful gain. Accordingly, I seized the above noted articles in presence of witnesses. I demanded him the papers or license, cash memo of the said liquor but he failed to produce any documents in support of possession of above noted illicit liquor. On interrogation, he disclosed his name as mentioned above and admitted that he procured the liquor illegally and selling the same illegally to the people. Then, I arrested him U/S 41 Cr.P.C. (The articles were seized in between 00.05 to 00.50 hrs)

Therefore I pray before your honour that a specific case may kindly be started against accused namely Ruk Bahadur Mukhiya (32) S/O Lt Lal Bahadur Mukhiya of Dimdima Busty Perna School, PO Salugara, Ps .Bhaktinagar, Dist Jalpaiguri as per proper section of law.
