Sir,

In producing herewith one arrested accused person namely Saloni Biswakarma (33) w/o Late Arjun Biswakarma of Maira Restaurant c/o Raaj Tamang of Salugara Bazaar, Behind Buddhist Monastery, PS Bhaktinagar, Dist. Jalpaiguri along with the seized articles viz: Twenty Seven (27) Bottles Of KINGFISHER STRONG PREMIUM BEER each BOTTLE containing 650 ml.

I, PSI Sailesh Subba of Bhaktinagar PS, SPC would like to lodge this written complainant against the above noted arrested accused person to the effect that on 14.11.2021 at around 14.05 Hrs while performing mobile van duty received a source information that one Lady has gathered huge amount of liquor illegally in her restaurant named and styled as "MAIRA RESTAURANT" situated at Salugara Bazaar, Behind Buddhist Monastery, PS Bhaktinagar, Dist. Jalpaiguri for selling the same to local customer for her wrongful gain. Accordingly I, informed you about the information and as per your kind instruction, I along with LC/1233 Jyatika Roy, C/374 Debraj Biswas, CVF/014 Labanyamoy Barman of Bhaktinagar PS/SPC headed towards Salugara to work out the information. At 14.25 hrs we reached at the spot, and after being shown by the source I, along with force entered the aforesaid Restaurant and apprehend one Lady who disclosed her identity as noted above and searched the Restaurant and recovered above noted seized articles. On demand of Licence or Documents for storing and selling the liquor, she could not produce the same. During enquiry she admitted her guilt before us and stated that she has been selling the same to local customer since long for her wrongful gain. I, then prepared seizure list of the above noted articles in presence of witnesses undersigned of seizure list. The seizure was made between 15.25 hrs to 15.45 Hrs. I arrested the said accused person u/s 41 Cr.P.C after observing all the formalities and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you to kindly register a specific case against the accused person namely Saloni Biswakarma (33) w/o Late Arjun Biswakarma of Maira Restaurant c/o Raaj Tamang of Salugara Bazaar, Behind Buddhist Monastery, PS Bhaktinagar, Dist. Jalpaiguri under proper section of law.
