With due respect and humble submission, in producing herewith one arrested accused namely Vishwanath Kumar (22) S/o Ram Nihora Mahato of Dagapur, Near Baba Lokenath Mandir Ps Pradhan Nagar Dist Darjeeling under arrest along with following articles under proper seizure ;

- i) 06(Six)bottles of Tuborg Premium Beer each bottle of 650ml.
- ii) 12(Twelve)bottles of Himalayan Gold 60up each bottle 600 ml

I PSI Sumit Sarkar of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 13.11.21 when I along with CV/223 Swapan Chettri, CV/992 Jagadish Biswas was performing Special Raid duty vide PDN PS GDE NO 682 dtd 13.11.21 .I received an information that one person namely Vishwanath Kumar has storage huge quantity of illegal liquor in his hotel styled as "Shiv Hotel" situated at Dagapur under Pradhannagar PS and selling the same in his Hotel. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and held raid in the shop noted above and detained the above noted person and on search his Hotel recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 19:45 hrs to 20:10 hrs and I arrested him after maintaining all formalities regarding arrest.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Vishwanath Kumar (22) S/o Ram Nihora Mahato of dagapur, Near Baba Lokenath Mandir Ps Pradhan Nagar Dist Darjeeling and arrange for its investigation.
