Sir,

In producing herewith two arrested accused persons namely 1) Nabin Ray (30) S/o Sarban Ray of Siliguri Junction, Rajendra Nagar, ward No-1, PS- Pradhannagar, Dist- Darjeeling (not verified) and 2) Arjun Prasad (20) S/o Shiv kr. Prasad @ Bata of Surya Sen Colony, Ratanlal Basty PS Pradhan Nagar Dist Darjeeling under arrest and the following property under seizure along with seizure list:-

- (i) 105 (One hundred and Five) bottles of REXDRYL-TM NEO (Codeine Phosphate & Chlopheniramine Maleate mixture) cough syrup each bottles contains 100 ml which contains Codine Phosphate 10 mg each and macked as Exhibit - "A"
- (ii) 01 (one) bottle of REXDRYL-TM NEO (Codeine Phosphate & Chlopheniramine Maleate mixture) cough syrup Manufactured In India by each bottles contains 100 ml which contains Codine Phosphate 10 mg randomly taken from exhibit "A" for examination and marked as exhibit- A-1,
- (iii) One yellow-orange combine colour strip nylon bag marked as B"
- (iv) One HONDA DIO Scooty, (Mat colour) bearing Reg. no WB 74 BF 7649.

I, ASI Tarun Kranti Ghosh, of Pradhan Nagar PS Siliguri Police Commissionerate do hereby submit this written complaint against above noted accused persons to the effect that on 14.11.2021 at 14:25 hrs, I received a reliable source information that one Nabin Ray along with Arjun Prasad coming from Jalpaiguri to towards Siliguri junction with huge consignment of contraband cough syrup in nylon bag by a scooty bearing Reg no. WB 74 BF 7649 for supplying the same illegally to adjacent areas of Siliguri Junction.

The matter was diarized vide Pradhan Nagar PS, GDE No. 738 Dt- 14.11.2021. Accordingly, I informed you and as per your direction myself along with PSI Sumit Sarkar, ASI Debasish Das, CV/128 Ajay Kr Sahani, CV/223 Swapan Chettri all of Pradhan Nagar PS Siliguri Police Commissionerate left for Siliguri Junction area by govt vehicle bearing no- WB-74AC 9851 to verify the veracity of the information accompanied by my reliable source. This refers to Pradhan nagar PS M C C NO.2773/21 Dt. 14.11.2021 which refers to Pradhan Nagar PS GDE no.739 Dt- 14.11.2021.

At the time of departure from the office, I took investigation kit and all necessary equipments. On way to the spot at Siliguri Junction, under PS- Pradhannagar. On reaching prior to the spot I contacted with two local people and found two disinterested persons namely (i) Sanjeet Das (19) S/o Bihari Das of Rajendra Nagar Cooliepara, PS Pradhan Nagar Dist Darjeeling ii) Shanker Chhetri s/o Dipak Chettri of Dewarli PS Dewarli, Gantok Sikkim. Then I informed them about the information in hand and requested them to accompany us in the whole process of search and seizure if necessary.

At about 15:05 hrs, we arrived at Siliguri junction and awaiting near SNT Bus stand. Few times later as pointed by the source we found that two persons was coming towards Junction by a Scooty in which a nylon bag was in the footrest of the scooty . We tried to stop them but seeing us they tried to flee away with scooty but we some how managed to apprehend them with the Scooty. On being asked the apprehend person disclosed their identity as noted above. On Further asked about the contains of the bag lying on footrest of the scooty they stated that they are carrying cough syrup for supply the same at junction area .

Then we detained them with strong reason to believe that the said persons are illegally possessing & selling the contraband cough syrup inside bag. After disclosing our identity, I asked them in writing, whether they wanted to be searched for presence of Executive Magistrate or Gazetted Officer for the process of Search and they agreed to be searched by any one of the two.

Subsequently I contacted to the Sri Subasisi Chaki ,I/C Pradhannagar PS SPC and requested to come to the spot and supervise the entire process of search and seizure as per law. Sri Subasisi Chaki ,I/C PS SPC arrived at the spot at 15:30 hrs. he disclose his identity before apprehended persons as gazette officer and they have been offered to search the police team as well as gazette officers and witnesses but they refused , thereafter the process of the search was started .


Then, as per direction and under supervision of Sri Subhashis Chaki, I commenced search the bag of the scooty and found above noted contraband cough syrup. On asking they failed to produced any valid documents in support of the contraband cough syrup. Then I seized the above noted articles through out the picketing sealing and labeling by preparing proper seizure list . The entire search, Seizure, label process has made between 15:55 hrs to 16:45. Hrs. and arrested the apprehended persons namely 1)Nabin Ray(30) S/o Sarban Ray of Siliguri Junction, Rajendra Nagar, ward No-1, PS- Pradhannagar, Dist- Darjeeling (not verified) and 2) Arjun Prasad (20) S/o Shiv kr. Prasad @ Bata of Surya Sen Colony, Ratanlal Basty PS Pradhan Nagar Dist Darjeeling for violating NDPS norms after maintaining all formalities regarding arrest.

In the above circumstance, I pray before you to take the seized articles and sample & arrested accused persons namely 1)Nabin Ray(30) S/o Sarban Ray of Siliguri Junction, Rajendra Nagar, ward No-1, PS- Pradhannagar, Dist- Darjeeling (not verified) and 2) Arjun Prasad (20) S/o Shiv kr. Prasad @ Bata of Surya Sen Colony, Ratanlal Basty PS Pradhan Nagar Dist Darjeeling and started a specific case against the arrested accused persons under proper section of law and arrange for its investigation.
