Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Mithun Mandal (29 yrs) S/O late Samchan Mandal (ii) Ananda Sarkar (26 yrs) S/O Ganesh Sarkar both of Tinbatti Kashmir Colony, PS- NJP, Dist.- Jalpaiguri and (iii) Pintu Roy (30 yrs) S/O Mantu Roy of Khatal Busty, Chaturagachh, PS- NJP, Dist.- Jalpaiguri and the following articles under seizure :-

1. One iron made sharp cutting weapons called as Bhojali from the possession of accused Mithun Mandal (29 yrs) S/O late Samchan Mandal of Tinbatti Kashmir Colony, PS- NJP, Dist.- Jalpaiguri.
2. One sharp cutting knife and one torch light and from the possession of accused Ananda Sarkar (26 yrs) S/O Ganesh Sarkar of Tinbatti Kashmir Colony, PS- NJP, Dist.- Jalpaiguri
3. One sharp cutting knife and one sharp cutting weapon called as hasua from the possession of accused Pintu Roy (30 yrs) S/O Mantu Roy of Khatal Busty, Chaturagachh, PS- NJP, Dist.- Jalpaiguri .

I, ASI Khagen Das of NJP PS, Siliguri Police Commissionerate beg to state that on 14.11.21 at 00.35 hrs I received a secret source information that a gang of miscreants come at near Fubari Bazar under PS- NJP, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Fulbari area. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No 532 dated 14.11.21. As per kind order and direction of my superior officer myself along with, C/1053 Paresh Rava, VP/13 Jamirul Islam, VP/08 Laxman Roy, CV/306 Bisawajit Roy, and CV/824 Niru Yadav left for Fulbari to work out the information in hand. I also informed the fact to night RT Van officer SI Shib Shankar Das and requested him to come to Fulbari Bazar to accompany with us. At about 00.55 hrs on 14.11.21 we arrived at Fulbari Bazar under PS- NJP, Dist.- Jalpaiguri. After a few time SI Shib Shankar Das along with force came to Fulbari Bazar and accompany with us. At about 01.25 hrs as indicated by the source we noticed that 8/9 persons assembled in a dark place at Fulbari Bazar and they were whispering in a very low voice. Accordingly, we cordoned the place properly and approach towards them very slowly and carefully but seeing the police party they started to flee away but we the police party managed to apprehended 03 (three) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted.

During further interrogation they give different statement in different time and filed to give any satisfactory reply for their presenc in middle of the night with deadly weapons. Finally they disclosed that they assembled there for committing dacoity at Fulbari area. Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested the above noted 03 (three) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure and arrest made in between 02.05 hrs and 02.55 hrs on 14.11.21.
