② That since few days he has been throwing
stones at my shop at the above mentioned
address and runs away.

③ That today i.e. 16/11/2021 ^{at around 8 pm.} he threw a
bigger size stone at me directly and
seeing that I somehow got saved there-
after he entered into my shop forcefully
and started assaulting me with fist
and blows and hit hard in my stomach.

and also danned my clothe and douched my chest and also I tried to touch my private parts. In the mean time he caught hold of my hair leg and tried to drag me, I some how freed myself from his clutches and ran for help and during that time he stole few articles from my shop and cash from my drawer around 5000/- and other articles. Seeing this the people near me started shouting at him and he out of fear ran from the spot.
