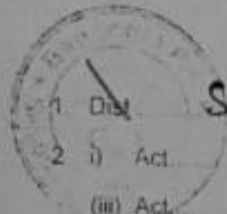

F.I.R.

I, the undersigned, most humbly state that on 04/11/2021 around 10 p.m. while my son Dayanand Ram was returning home from his work place and when he reached near the home he saw Sri Sanjay Paul, ex Panchayat member, Sri Joy Roy s/o Amal Roy were discussing with one water pipe line worker. Then suddenly our neighbour Sri Bikky Majhi s/o Gajendar Majhi caught hold of my son's collar and tried to strangulate him with his bare hands. At that time upon hearing hue and cry I came out of my home to save my son. At that moment Sri Gajinder Majhi s/o Bijli Majhi and his daughter Neha Majhi, his wife and his younger brother's wife started to beat me with fists and blows and with a stick younger brother's wife assaulted upon my head with a stick and others continued to beat me. My daughter-in-law Lalti Kumari (wife of Dayanand Ram) was also not spared by them when she was trying to save me and my son.

I and my son Dayanand Ram received several serious injuries. I got hurt upon my head and other parts of my body and my son received injuries upon his hand and other parts of body.

I am still under extremely fear and my treatment has been still going on and as such delay has been caused to lodge the information.

I therefore request you to start a strong case against culprits who are residents of the same village where I am staying and oblige.
