

F.I.R. FOR PHYSICAL ASSAULT

Respected Sir,

I, Gajendra Majhi, son of Kapil Dev Majhi, R/o. Balaram Nagar, Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, INDIA, would like to state that on 04 / 11 / 2021 at around 9.30 P.M when I & my son Niraj Majhi @ Biki Majhi was standing near my gate and talking with my neighbour about water pipe line suddenly one of my neighbour namely (1) Deochand Ram, S/o. Unknown Ram, (2) Dayanand Ram, R/o. Deochand Ram, (3) Wife of Dayanand Ram (name not known) & (4) Wife of Deochand Ram (name not known), ALL R/o. Balaram Nagar, Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, INDIA, came in front of my house and attacked my son & me with sharp wooden batam. They physically assaulted my son due to which my son sustained injuries in his chest & head. My son was bleeding at that time. I also sustained internal injury in my right hand. Hearing by hue and cry when my wife & my brother's wife came to rescue me and my son the abovenamed persons physically assaulted them also. Deochand Ram & Dayanand Ram caught hold of my wife and my brother's wife and tried to disrobe them forcibly. They even tried to touch their private parts. They torn my wife's blouse and my son's t-shirt. I and my family members anyhow get rid of their cruel hands and ran into our house.



I was totally shocked as I am a family man & I have never fallen into such situation. These persons are antisocial elements of the society and they have no respect in the locality. After the said incident Dayanand Ram started verbally abusing my daughter namely Neha Majhi in roads. The very next day i.e. on 05/11/2021 at about 10.30 A.M. Smt. Sunita Ram, daughter of Deochand Ram & Smt. Jyoti Ram, daughter of Smt. Sunita Ram again came in front of our house and started threatening me and my family members. They also used abusive language to us. I am in danger and I have strong belief that they would again do the same thing and harass us mentally & physically. I am a poor person and Deochand Ram & his family are rich and they always shouts at us and says that I am bhikari and I have no right to reside beside their house. They have made our life hell. I and my family members do not talk with them but they always harass us.

It is requested before you in folded hand to kindly take strict necessary action against the abovenamed persons so that they can be punished for this illegal act. I was late to lodge the FIR as I was in mental trauma.
