Sir,

I, the undersigned, Smt. Jashoda Singh Barman wife of Sri Sudhir Barman daughter of Late Bhupal Singha of Sukanta Nagar (Dara Gaon) P.O & P.S.:- Bagdogra, Dist. Darjeeling, W.B. in rented premises do lodge this complaint as stated in the following :-

1. That in the month of 13<sup>th</sup> July 2006 (28<sup>th</sup> Ashar 1413 Shan) I got married with said Sudhir Barman s/o Anil Barman (father-in-law) & Anika Barman (mother-in-law) of Kalagach, P.S.- Chopra, Dt. :- Uttar Dinajpur W.B. at Naxalbari in my paternal home according to Hindu rites and customs.
  2. That my husband has been working in Mahindra Co. and other companies and he has a good income.
  3. That since after a month from the date of marriage, I noticed that my husband keeps illicit relationship with other women. On questioning he used to deny but after some months he not only disclosed his illicit affairs with other women but openly said that he will keep such illicit relationship and do not fear to do so. Thereafter I complained to my in-laws but my in-laws also supported their son and said that it is his choice and it will be better for you to dissolve the marriage by divorce. With passing of days my husband used to assault me whenever I used to question him about his illicit relationship with the full support of his parents/my in-laws.
  4. That out of the sense of propriety I continued to bear all the mental and physical tortures upon me by my husband and in-laws.
  5. That since last one year I have been staying with my husband and my two minor daughters at Sukanta Nagar (Dara Gaon) P.O & P.S.:- Bagdogra, Dist. Darjeeling in rented premises.
- That at Bagdogra he has been again involved in many illicit relationship and on 12/11/2021 in the afternoon at around 12.15 p.m. when I asked my husband as to why he is indulging himself in such illicit activities as our daughters have grown up to understand the consequences of such bad activities. Then he badly assaulted me with fists and blows and also took out a Khukri and threatened to kill me if I resist him in such activities.

8. That I am under constant fear of getting killed and so do not intend to go back to my husband's place at Bagdogra, Darjeeling W.B. and due to immense mental pressure , fear and trauma there has been delay to lodge this information/complaint

I therefore request you to take immediate strong action against Sudhir Barman and others and oblige.
