I, Smt. Sabitri Barman W/O Sri Bartha Barman, resident of Near Kalibari, Kestopur, P.O. Chowpukuria, P.S. Bagdogra, Dist. Darjeeling, beg to report you that yesterday i.e. 16.11.2021 at about 8.00 p.m. when I was doing my household chores suddenly my husband Sri Bartha Barman S/O Sri Fakaru Barman of Near Kalibari, Kestopur, P.O. Chowpukuria, P.S. Bagdogra, Dist. Darjeeling came home in a drunken state and without any rhyme or reason and without any provocation started to hit me with lathi with an intention to kill me for which I received grave and serious injuries in my head, neck, chest, back and hand which resulted in serious bleeding from my forehead as a result I am suffering from severe pain. That he pushed me and hit me in my face and thereafter I was thrown on the ground and thereafter my father in law Sri Fakaru Barman S/O Late Kaluram Barman of Near Kalibari, Kestopur, P.O. Chowpukuria, P.S. Bagdogra, Dist. Darjeeling joined my husband and started to hit me mercilessly with fists and blows with an intention to kill me.


They have also threatened me that if I report the matter with police then I will have to face dire consequences as they do not fear anyone and they have also threatened me that they will implicate me in various false cases as they are very powerful in the locality and that no one can do anything to them.

That thereafter I was taken to Bagdogra Hospital by my sons Biplab Barman and Ram Kumar Barman wherein I received necessary treatment. I was grievously injured which has been mentioned in the Emergency Ticket issued by Bagdogra P.H.C., Bagdogra (Copies attached). I was then discharged from the hospital with instructions to get my CT Scan done at the earliest. I, therefore, request you to enter my report in the G.D.E. maintained by you so that necessary action may be taken against the accused persons mentioned above.
