Sir,

In producing herewith one person namely Sanjay Jaiswal 31 yrs s/o Pradip Jaiswal of Panighata Road Upper Bagdogra PS Bagdogra Dist Darjeeling along with the following articles under seizure viz.

1. 15 (Fifteen) bottles of Himalyan Gold 60' Up country Spirit (each bottle containing 600 ml.) marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A-1".
2. 10 (Ten) bottles of Mc Dowells No -1 Celebration Rum (each bottle containing 750 ml.) marked as Exhibit "B" from which 01 bottle randomly taken out as sample and marked as Exhibit "B-1".
3. 07 (Seven) bottles of Mc Dowells No -1 Luxury (each bottle containing 750 ml.) marked as Exhibit "C" from which 01 bottle randomly taken out as sample and marked as Exhibit "C-1".
4. 11 (Eleven) bottles of Sterling Reserve Whisky Blend (each bottle containing 750 ml.) marked as Exhibit "D" from which 01 bottle randomly taken out as sample and marked as Exhibit "D-1".

I, ASI Dharendra Nath Mandal of Bagdogra Police Station, SPC do hereby lodged this complaint against the above noted arrested person named Sanjay Jaiswal 31 yrs s/o Pradip Jaiswal of Panighata Road Upper Bagdogra PS Bagdogra Dist Darjeeling to the effect that today i.e., on 18.11.2021 in course of special mobile duty vide Bagdogra PS, GDE No 625 Dt, 18.11.2021 at about 19.15 hrs received source information that one person is selling illicit liquor at Upper Bagdogra Panighata road from the shop of Pradip Hotel and huge quantity of illicit liquor is stored in his shop. Accordingly, I shared the information with you and as instructed had been to Upper Bagdogra Panighata road to work out the information. On reaching there at about 19.35 hrs, I contacted with my source and subsequently being pointed apprehended the above noted person who being asked disclosed his identity as above and stated that he is the owner of the shop while during cordoning of the shop some customers having liquor on the shop and fled away. Subsequently the above noted articles were found in the shop of said Sanjay Jaiswal who, being asked failed to produce any valid documents/papers in support of possessing and selling of the liquor and further admitted that he is involved in such trade for last few months. Accordingly, I seized the liquor found at his shop under proper seizure list and labelled and also arrested him u/s 41(A) CrPC issuing memo of arrest. The whole process of seizure and labelled was made in between 19.40 hrs to 20.20 hrs. Total 30 liters illicit liquors has been seized.

Therefore, I pray that a specific case under proper section of law may kindly be recorded against above noted Sanjay Jaiswal 31 yrs s/o Pradip Jaiswal of Panighata Road Upper Bagdogra PS Bagdogra Dist Darjeeling and arrange for its investigation.
