**Sub: FIR in connection with the abusive behaviour and physical violence which occurred near my husband's food stall at Porajhar Village.**

I, Khushi Das, resident of Kawakhali Township, Siliguri, would like to submit before you as under:

Last night on 12.11.2021, at around 7:30 pm, while I was sitting in my brother - Sri Jhuten Mandal's food stall at Porajhar village; a group of 7 people namely Tara Sarkar, Amrita Sarkar, Bipasa Sarkar, Neha Sarkar, Pooja Sarkar, all residents of Porajhar Village along with one resident of Shantipara, Ambikanagar namely Nayan who happens Pooja Sarkar's brother came there and started abusing my sister in law namely Pinky Mandal. I had gone there to distribute Chaat Puja prasad to my brother.

Amrita Sarkar and Tara Sarkar first came inside and suddenly started abusing me and my sister in law Pinky Mandal.

When I resisted, Amrita Sarkar, Bipasa Sarkar, Neha Sarkar and Pooja Sarkar came together to attack me and my sister in law.

Pooja Sarkar bit me in my stomach with her full strength.

Bipasha Sarkar scratched my sister in law's entire stomach with her long nails.

They caught hold of her hair and were hitting me badly.
